### **Requested Action:**

It is requested that the Board approve a 60-day extension to the existing contract for Special Magistrate Services for Code Violation, Vested Rights, and Unlicensed Contractor Hearings and authorize the Chair to sign the resulting contract extension upon review by the County Attorney's Office and Risk Management.

# Summary Explanation and Background:

On February 12, 2019, the Board authorized advertising a Request for Qualifications for Special Magistrate Services to hold hearings for unlicensed contractors and vested rights cases; approved establishing Selection and Negotiation Committees consisting of John Denninghoff, Assistant County Manager, Tad Calkins, Planning and Development Director, and Jerry Visco, Human Resources Director, or their designee; and authorized the Chair to execute resulting contract upon review by the County Attorney's Office and Risk Management.

A Request for Qualification was advertised on April 11, 2019 for a period of 21 days in accordance with Policy. Upon completion of the required advertising time the County received no responses to the Request for Qualification.

The County has continued to utilize the services of Mr. Stewart B. Capps for Special Magistrate Services for Code Violations under the current contract. Mr. Capps is also serving as the alternate Special Magistrate for unlicensed contractor and vested rights hearings.

Staff has reached out to Mr. Capps to discuss his interest in extending the current contract under the same terms and conditions that is set to expire in February 2020. Mr. Capps agreed that he would be interested under the same terms and conditions.

Based on this information and the lack of responses to the initial Request for Qualifications for Unlicensed Contractor and Vested Rights Hearings, Staff is requesting the Board approve a contract extension based on F.8. 1/7/2020

the same terms and conditions while the Request for Qualifications Solicitation Package is revised to include Special Magistrate for Code Violations in conjunction with Unlicensed Contractor and Vested Rights Hearings and authorize the Chair to execute the contract extension which has been reviewed by the County Attorney's Office and Risk Management.

#### AGREEMENT TO EXTEND EXISTING CONTRACT

THIS AMENDMENT TO THE CONTRACT, is made and entered into on this7
day of January 2020, by and between the Board Of County Commissioners of Brevard County,
Florida (the "County") and Stewart B. Capps ("Special Magistrate") having a business location at

#### WITNESSETH:

**WHEREAS**, the County previously entered into a Contract dated February 3, 2015 and first renewal dated February 3, 2016, second renewal dated February 3, 2017, third renewal dated February 3, 2018, and final renewal dated February 3, 2019 for the purposes of providing Special Magistrate Services to the County as a result of a competitive solicitation and evaluation of applications;

**WHEREAS**, the Parties desire to extend the Contract term for an additional sixty (60) days to provide sufficient time for solicitation and evaluation of applications for Special Magistrate Services.

**NOW THEREFORE**, the parties wish to extend the Contract dated February 3, 2019 as follows:

- **1.** The term of the Contract executed by the parties effective February 3, 2019 shall be extended for sixty (60) days terminating on April 3, 2020.
- **2**. All other terms and conditions of the Contract, which is incorporated herein by this reference, not inconsistent with the terms and provisions of this Amendment, shall remain in full force and effect.
