I would like to request approval of an amendment to the plan to distribute District 4's allocation of CARES funds approved by the Board on November 5, 2020.

On January 12, 2021, the Board of County Commissioners granted approval of up to an additional \$20,000 to small businesses that have shown equivalent loss of revenue from March to June 2020. Payments have been made to all eligible businesses that qualified under this program for businesses in Districts 1, 3, 4, and 5.

There are funds remaining in District 4's allocation.

I move to:

1. Approve an additional grant of \$39,700 to the businesses listed on the attached page, from the remaining allotted District 4 allocation, for grants to businesses which, based on documentation submitted to the County, show unreimbursed losses from March to June 2020, that exceeded federal and local benefits received; and
2. Administrative costs for distributing the funds shall be deducted from the District 4 allocation; and
3. Authorize the County Manager to sign any necessary documents related to the distribution of the District 4 allocation to those on the list.
