Good morning,

The recon report shows it as a speaking engagement. The commissioner was speaking to the Cocoa Beach Kiwanis Club regarding county issues. There was a flat rate of \$10/per meal (however at the time I was told \$12/per meal) which included a drink. The meals were tacos and taco salads. The attendees were all members of the District 2 office per the commissioner's request. Kika Golan, Susan Smith, Kerensa Slocum and Commissioner Goodson attended. He requests our attendance so that we are available to address issues any attendees may have and/or get their names and phone numbers for call back.

The commissioner would like to have a total for the tax and the gratuity that needs repayment (and anything else you instruct) so that he can pay it as he does not want to worry about the process for rescinding the tax on the Publix orders. The total we came up with is \$26.28 thus far. Please advise if this is the correct amount. Then I will send the check, and a copy of the Publix receipts and the Mexican restaurant receipt to accompany the repayment. Yes, If you pay both Publix tax dated 11/30/23 & 12/08/23 and the gratuity from the restaurant. The taxes on the 12/08 should fall on the Recon report of January closing date. You can put a little note on the receipt that it was paid back. (and add this email if you'd like.)

We already submitted a recon report for the upcoming meeting on January 9,. 2024. However, I can ask that they remove it since it will need correction and repayment if necessary – please advise. Can you explain how the tax repayment would be reflected in the recon report to show that tax was repaid? for the recon report 12/04 I will note on my end on the first page correction made for gratuity and taxes (see email).

Since we don't typically use the purchase card, these issues were an oversight on my part especially when I was told the dinners were \$12 per person, not realizing \$2 per person was gratuity. I will make sure to double check should we use it again in the coming years. Also, the same with the food. Typically not taxed but I'm guessing since it was personally prepared, it was different. My apologies.

Thank you for your patience and cooperation. Please advise on the above.
