Drug courts take a holistic approach to help clients turn their lives around by teaching clients how to overcome other burdens related to addiction. # Treatment Drug Court Month Proclamation (Please Frame)

**WHEREAS,** this year marks the 30<sup>th</sup> anniversary of treatment drug courts and the establishment of more than 3,000 of these courts nationwide since 1989; and

**WHEREAS,** treatment drug courts represent the cornerstone of justice reform sweeping the nation and have served more than 1.5 million individuals; and

**WHEREAS,** treatment drug courts are recognized as the most successful justice system intervention in our nation's history and save an average of \$6,000 for every individual they serve; and

**WHEREAS**, treatment drug courts significantly improve substance abuse outcomes, substantially reduce addiction and related crime, and do so at less expense than any other criminal justice strategy; and

**WHEREAS,** treatment drug courts improve education, employment, housing and financial stability, promote family reunification, reduce foster care placements and increase the rate of addicted mothers delivering babies who are fully drug free; and

**WHEREAS,** treatment drug courts facilitate community-wide partnerships, bring together public safety and public health professionals, and demonstrate that when one person rises out of substance use and crime, we all rise; and

NOW, THEREFORE, BE IT RESOLVED THAT THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA, declares the month of May 2019 to be Treatment Drug Court Month;
