Requested Action:

Approval of Florida Today for the advertising of delinquent property taxes for next three years (2018, 2019, 2020).

Summary Explanation & Background:

FS 197.402 requires the Board of County Commissioners to choose the newspaper for advertising delinquent real estate taxes so tax certificates can be sold; and for the advertising of delinquent personal property taxes so tax warrants can be issued. Florida Today has extended the same rate as previous years for the next three years (see attached).
