§ 102.141 (1) (c), Fla. Stat., states: "If the chair of the board of county commissioners is unable to serve or is disqualified, the board of county commissioners shall appoint as a substitute member one of its members who is not a candidate with opposition in the election being canvassed and who is not an active participant in the campaign or candidacy of any candidate with opposition in the election being canvassed." As Commissioner Lober is an active participant in the campaign or candidacy of Rachel Sadoff, who has opposition in the election being canvassed, Commissioner Lober is statutorily disqualified from serving on the Brevard County Election Canvassing Board. As all other commissioners are seeking reelection in 2020, it is Commissioner Lober's recommendation that Commissioner Smith be selected to serve on the canvassing board.
