It is requested that the Board of County Commissioners approve a Resolution recognizing October 2022 as Domestic Violence Awareness Month.

Summary Explanation and Background:

Per the National Coalition Against Domestic Violence:

- 1 in 4 women and 1 in 9 men experience severe intimate partner physical violence, intimate partner sexual violence, and/or intimate partner stalking with impacts such as injury, fearfulness, post-traumatic stress disorder, use of victim services, and contraction of sexually transmitted diseases.
- Victims of intimate partner violence lose a total of 8.0 million days of paid work each year and the cost of intimate partner violence exceeds \$8.3 billion per year.

Therefore, the month of October 2022 has been designated Domestic Violence Awareness Month to bring awareness to and enlist citizens to speak out against domestic violence.

Members of the Domestic Violence Task Force will accept the resolution.
