### Requested Action:

It is requested that the Board of County Commissioners approve and accept the attached Warranty Deed.

### **Summary Explanation and Background:**

The subject property is located in Section 23, Township 30 South, Range 38 East, on the west side of Central Avenue in Micco.

Natural Resources Management Department is planning a stormwater improvement project known as the Micco Master Stormwater Project. The plan is being developed to address numerous maintenance and flooding issues for Basin 2169, which has minimal stormwater treatment before discharging into the Sebastian River.

A portion of historical flow traverses the tracts of Briere Subdivision. The tracts have not been properly maintained, resulting in an obstruction of stormwater flow. This obstruction causes flooding of upstream properties. The donation of these tracts will allow for proper maintenance to ensure flow and will benefit the overall project.

In an effort to support the project, the owner of the plat of Briere Subdivision has agreed to donate the subdivision tracts.

The User Department approves this request.
