Request for Extension of Existing Agreement with Advanced Data Processing, Inc, a Subsidiary of Intermedix Corporation, from October 1, 2019 to December 31, 2019.

### Requested Action:

The Fire Rescue Department requests approval to extend its current contract with Advanced Data Processing, Inc., a Subsidiary of InterMedix Corporation for an additional extension period from October 1, 2019 to December 31, 2019, to facilitate contract negotiations and implementation time required for the newly selected vendor, Change Healthcare Technology Enabled Services, LLC, to begin providing patient billing services.

### Summary Explanation and Background:

On May 21, 2019, the Board approved the extension the current ADPI/Intermedix billing services agreement to September 30, 2019, to facilitate the execution of the RFP process. The RFP process has proven to be lengthy; currently, the County Attorney's Office and Fire Rescue staff is in active contract negotiations with the selected vendor. Successful conclusion of the contract negotiation is expected to occur very shortly. When the contract for billing services is approved and enacted, Change Healthcare Technology Enabled Services, LLC, the selected vendor, will require additional time for implementation of their software system to provide BCFR with uninterrupted patient billing services.

The Department is requesting an additional extension period, through December 31, 2019, to the ADPI/Intermedix billing services agreement to allow sufficient time for the newly selected vendor assume billing services. ADPI/Intermedix has agreed to the extension to December 31, 2019.

**AMENDMENT EXTENDING EXISTING CONTRACT**  
**FOR EMERGENCY MEDICAL SERVICES BILLING AND RELATED PROFESSIONAL SERVICES**

THIS CONTRACT AMENDMENT is made and entered into this 17<sup>th</sup> day of September, 2019, by and between the following Parties: Advanced Data Processing, Inc. a Subsidiary of InterMedix Corporation, and the BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA, a political subdivision of the State of Florida.

**WITNESSETH:**

**WHEREAS**, the Parties previously entered into a Contract to perform patient billing services and related professional services for Fire Rescue's Emergency Medical Services (EMS) within Brevard County on March 3, 2014, as amended on November 1, 2016, and then extended its term to September 30, 2019; and

**WHEREAS**, the Parties desire to extend the Contract term for an additional ninety-two (92) days to provide sufficient time for the newly selected patient billing services vendor to assume billing services.

**NOW, THEREFORE**, the Parties mutually agree as follows:

1. The term of the previous Contract between the Parties is amended to provide a Third extension from October 1, 2019, to a new expiration date of December 31, 2019.
2. With exception of the term extension, all the terms and conditions of the Contract dated March 3, 2014, as amended on November 1, 2016, remain in full force and effect with no modification.
3. Each Party warrants that the person signing on its behalf has been fully authorized by all required action to sign on behalf of and to bind that Party to this Contract Amendment.




