REQUESTED ACTION:

Staff requests that the Board of County Commissioners (BOCC) adopt a resolution authorizing Kevin R. Bodge PhD, PE of Olsen Associates, Inc. and Mike McGarry, Program Manager for Beaches, Boating and Waterways, to make engineering and project management related commitments on the County's behalf in condemnation proceedings regarding the Brevard County Shore Protection Project – Mid Reach Segment.

SUMMARY EXPLANATION and BACKGROUND:

In the continuing effort to plan and construct this project, it is requested that the Board formally authorize the project engineer, Kevin R. Bodge PhD, PE of Olsen Associates, Inc. and Mike McGarry, Program Manager for Beaches, Boating and Waterways, to make commitments on behalf of the County during court proceedings regarding the use of land necessary for construction of the Brevard County Shore Protection Project – Mid Reach Segment. It is intended that Mr. Bodge and/or Mr. McGarry will be called as expert witnesses regarding the project at upcoming court proceedings in the condemnation action. The purpose of the resolution is to show the court that both witnesses are authorized by the County to make representations about the project construction and use of lands acquired and bind the County by their testimony. This Board has adopted similar resolutions authorizing an expert to bind the Board regarding construction plans in other condemnations cases.
