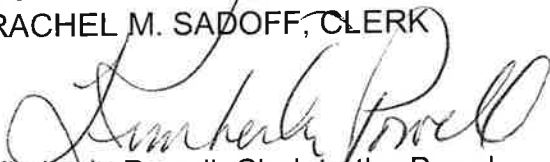

“An independent special tax district is hereby created and incorporated, as a political subdivision of the state...”

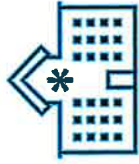

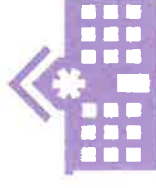

Public vs. Private



Public Hospitals

Funding	Taxpayers (PMC \$0 - 30+ years)
Costs	Lower
Services	Broader access for uninsured/low-income
Governance	Publicly appointed governing board; unpaid; local residency required
Transparency	Higher; Public board meetings; Sunshine Laws; heavily regulated
Growth/Competition	Restricted to District Boundaries



Private Hospitals

Funding	Private Investors
Costs	Higher
Services	Serve primarily to commercially insured
Governance	Privately appointed governing board; often paid positions; local residency not required
Transparency	Lower; private board meetings; Sunshine rules do not apply
Growth/Competition	Unrestricted

Board Member Appointments

The role of the Brevard County Board of County Commissioners

The role of the Board of County Commissioners is outlined within Parrish Medical Center's Enabling Legislation and relates directly to the appointment of six of our nine-member Board of Directors.

This assures that the public is adequately represented.

First, Board members one, two, and three shall be appointed by the **City Council of the City of Titusville.**

Then, Board members four, five and seven shall be appointed by the **Board of County Commissioners of Brevard County**.

According to the Enabling Legislation

And, Board members six, eight and nine shall be appointed by the **Board of County Commissioners of Brevard County** subject to the confirmation by the **City Council of the City of Titusville**.

Board of Directors Self Assessment

(the Act) mandates all FISOs, including hospitals, conduct and submit performance reviews of their operations, inclusive of all programs, activities, and functions they provide to their communities.

Independent Review

In June of 2024, the final reports are to be delivered to the Board of Directors of Parrish Medical Center, the Auditor General, the President of the Senate, and the Speaker of the House of Representatives.

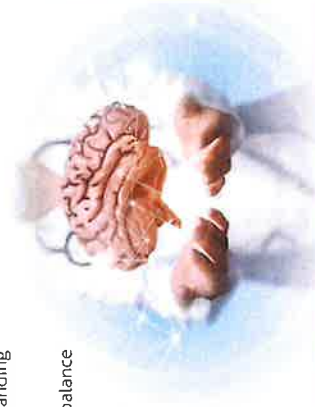
Stroke is a leading cause of death in Florida. Certified Primary Stroke Centers, like Parrish Medical Center, have demonstrated stroke treatment excellence.

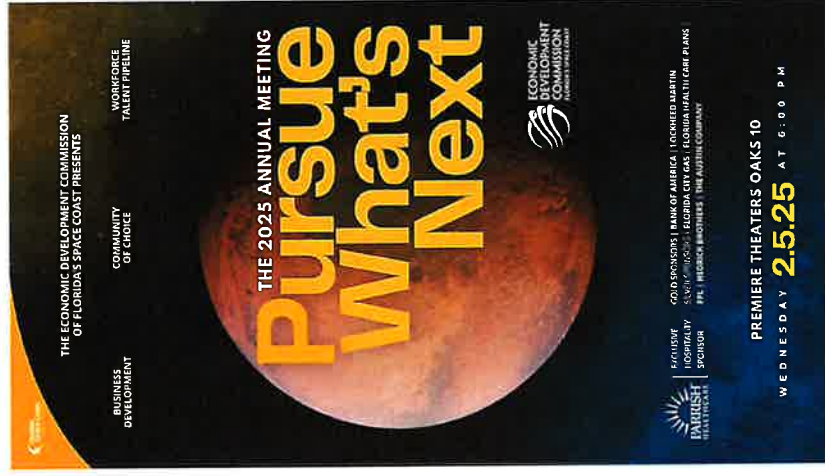
