Item IV., Board Discussion for Coronavirus Aid, Relief, and Economic Security Act (CARES Act) Coronavirus Relief Fund (CRF)

Pritchett – No, sir, but I do have a motion I'd like to throw out there right now.

Lober - Yes, ma'am.

Pritchett – Just listening to all the conversations that each Commissioner of every District be allocated five million to do what they would like to do. I would like to take five million and put it at Parrish. You could give it to Health First. You could do the Port and then you guys could pick them, because I think that because of personal reasons we overlook some things that I think are very important for us to fund. So, I would just like to make a motion that each Commissioner be given five million to allocate to their District on something that's appropriate COVID related.

Lober – Commissioner, before I second that, would you consider modifying that to mandate that the distribution be to items that are evaluated and considered by Tetra Tech to be low risk?

Pritchett - Yes, sir.

Lober - Okay, I'll second it in that case.

Pritchett - Yes, Sir. Can I call the motion?

Smith - Second.

Lober - Alright, too late Commissioner Smith, I've already seconded it, sir.

Tobia – How. How. I just. How much money is left over? Uh, I mean, we're just throwing millions of dollars around right here. And. And this. This creates all sorts of problem obvious problems. Uh. Uh. So, what happens if you wanted to do something crazy like something I would want to do and.

Lober - Pluck us from office.

Tobia – Spend money on Fire Rescue that benefits the entire County, instead of say an entity that's located exclusively within a Commission District.

Isnardi - Yeah.

Tobia – I mean, it's time that we get out of our individual Commission Districts, and start looking at what's good for the entire Brevard County here.

Lober - Commissioner, I...

Pritchett - I.

Tobia – When you create these pots of money it becomes absolutely ridiculous. It's got to be bad for staff. Uh, the leftover money, we, we found a way we can put it in that public safety thing, and Lord knows it'll go to, uh, fire safety, and, and the share, and the Sheriff's Office but.

Lober - Commissioner, I really want to be nice to you, sir.

Tobia – Don't!

Lober - And.

Tobia - Then don't!

Lober – I'm really trying to be diplomatic right now.

Tobia - Don't, I just got out of an election, so I'm used to it.

Lober – I'm really. I'm struggling with it though at the moment because, as far as making the pitch that we need to do things that benefit the entire County, the items that benefited a substantial portion of the County that didn't happen to have the same overlap with your District, you were very quick to dismiss earlier. So, it just seems to me, that really the argument is seeking to achieve the opposite. Things that benefit District 3 or portions of the County that also include District 3.

Tobia – That. That argument.

Lober - So, it just strikes me the wrong way.

Tobia - That argument, again is, is, is completely flaccid. Uh, in so much as I want to give the.

Lober – A flaccid argument, sir?

Tobia – It's certain. It's certainly not turgid.

Smith - I wouldn't. I wouldn't know what that is.

Lober – I consider all of my arguments are turgid.

Isnardi - Curt, I caught that.

Tobia – Yeah.

Lober - Oh, God! Okay.

Tobia – It's getting late here and we have another meeting. Now, I've said. I've showed my cards off the table at the beginning. I said it should go in the Public Safety. My. My. My money, uh, if, if I'm given \$5 million or whatever will go into the Public Safety Fund. I would hope everyone would do the same, if you want to hand this out. We just. We just did this. I. I. You, we gave \$200,000 to dogs, because it was important to you, and, and that's fine but why, why are we.

Lober – Yes.

Tobia – I don't even know how much money is left.

Lober – Yes, it was important to me but again, the two organizations weren't selected because I just happen to like them, these are organizations both that end up performing a service that would

otherwise fall in the County. So, you know, I, I can tell you, I, I don't recall having given either of those two organizations a penny of my own money. I've given a lot of money to animal rescue organizations, but none of them have shelters which is the reason those two were selected.

Tobia - I'm gonna lose. I got this, uh, yeah, I'm gonna lose this one Mr. Chair. Uh. Uh.

Lober – Well, we have a motion and a second.

Tobia – Yeah, Commissioner Pritchett, well how did you choose five million dollars? Why not? Why? Why don't we spend it all?

Pritchett - Well.

Tobia – Why don't we?

Pritchett - Well.

Tobia – Why don't we divide it?

Pritchett – Well, because you're saying these are District specific, and they are. So, then there's an opportunity for other District specifics. This is important. There was so many personal things going on with this, on projects that should have approved, so I thought this was really good. We can do what we need to do that we feel is important in our own District and, and if it's exactly what you said in that criteria that it's low-risk and it's something that's really benefiting the community. So, I really like this motion.

Lober – And I mean, if someone feels compelled, uh, Commissioner Tobia for instance to put this toward BCFR exclusively, there's nothing that precludes you from doing that. I don't see any issue with that. Uh, Mr. Abbate.

Abbate – You know and I should have, you know, I fault myself on this. So, let me say one other thing that.

Lober - Sure.

Abbate – Um, when I did that presentation I went through it all and I skipped one. Not one item, I mentioned it, but we didn't, the Board didn't take action on it, and it wasn't really written here separately, and that was the 11 million dollars, \$11.2 million that was the EMS transport going into the fire fund. I don't know if the Board intended, wanted to deal with that issue but we went through the list it wasn't listed there, so, I forgot.

Lober - Okay.

Abbate - We didn't think of doing it. With that, if before you consider that.

Lober - Yes.

Abbate – If you chose to consider that that was \$11.2 million. We have 49 million, 604, thousand, 683 that is, currently would go into whatever, and of course what you guys wanted to do with it.

Lober – So, what does that lease us, as far as the amount, after assuming we allocate 11 million, 136 thousand 356.

Abbate – If. If. That would leave you. That would leave you, uh \$38 million and if you did \$5 million each that would put \$13 million, approximately \$13 million into the public safety, and then whatever you did with the \$5 million each that number could go up.

Lober – Mr. Abbate, I just want to be sure because we were talking at various points in time some in the Commission meeting and then us individually outside of the Commission meeting of doing BCFR as one pot, and BCSO as another pot. I'm not necessarily opposed to combining them

Abbate - The. The \$8.8 million would still be a separate pot that the Sheriff would have.

Lober – Okay. But if we, because what I'm looking at is I want to make sure, the one thing to me, and I'm sorry Commissioner Pritchett, to kind of diverge from the motion that you put forth. I want to be absolutely certain that as to the Countywide EMS transport costs, we allocate everything that we're entitled to allocate for that. That benefits everyone.

Abbate – That would be \$11.2 million and we did not address that issue separately.

Lober – But we, but certainly with respect to this we have more than ample funding leftover in order to allocate that.

Abbate - Yes.

Lober – And still have money to look at. So all right, we have a motion, we have a second.

Isnardi – I'm about as uncomfortable not knowing where we are financially. I need to see a spreadsheet with some numbers on it because we are all over the damn place and I don't like any of this.

Abbate - Those are the numbers.

Isnardi – No. What I'm saying is where we are because we keep messing with these numbers, I don't know how much money is left? I want to make sure.

Lober - We have about \$38 million left. Is that not correct?

Hayes - If I can, we started out with \$51.1 million. We've been keeping a tally, myself, Kathy, and someone in the Budget Office, Chelsea, in the Budget Office. So, I can give a recap. We allocated \$2.2 in Individual Assistance, \$1.5 in Small Business support, we unallocated three million, 593 thousand, 928 dollars to the School giving them a max of \$4 million, we put \$190,000 into Animal Rescue groups, \$500,000 into the Zoo, \$500,000 into mental health Circles of Care, \$130,000 into Urgent Care, \$74,400 into Aging Matters/Meals on Wheels, and \$29,662 dollars into the Homeless Coalition/Family Promise of Brevard. So, we are now at 49 million, 604 thousand, and 683 dollars. With the \$11,136,356 dollars that Frank just mentioned for Countywide EMS transport that would take us to 38 million, 468 dollars, and 327.

Lober - Okay.

Hayes – And, I have it in a spreadsheet.

Lober – So, I apologize, but we have a motion on the floor with a second, so unless the motion's withdrawn.

Tobia – I do have a question, Mr. Chair.

Lober – Just very briefly, Commissioner.

Tobia — I just Googled, uh Commissioner Pritchett, I just Googled uh, strip clubs in Brevard County, and I see there's five. Dancer Royale, PinUps of Palm Bay, The Red Leopard, Lido Cabaret, and Bare Assets. My question is. And Cheaters. I'm sorry, I don't, and I guess there's six. Um... Would you be comfortable with me going to them and saying that we have CARES dollars and the Board has authorized, the Board, you're part of that, has authorized me to find out what you may be eligible for, and assuming that comes back that that were eligible you would be on Board for voting for, uh, I don't know? Strip clubs.

Pritchett - What planet are you on with that? We're talking about hospital, hospital, Port, and if.

Tobia – But you just gave.

Pritchett - And you come back. We're doing that with small.

Tobia - Discretion to do whatever as long as it was.

Pritchett – We're doing that with Small. No! It has to be. It has to be on low-risk and those are small businesses, if they already put in that would be run through with, with whatever.

Tobia - Well? If. If.

Lober – I'm going to Call the Question at this point.

Pritchett - Thank you.

Lober – This is just. I apologize. But, I don't think this is productive. All right, so we have a motion and a second. This is to allocate or to authorize the individual Commissioners to spend up to \$5 million a piece. Did you say within their District, or do you care if it's anywhere in the county?

Pritchett – I don't care. Anywhere in the County, but it has to be low-risk.

Lober – Okay, anywhere in the County and then my second stand with respect to that. It's got to be evaluated by Tetra Tech, found to qualify, and found to be low risk, not moderate or high-risk. Within those confines that's what we're voting on. All in favor say Aye.

Pritchett - Aye.

Lober - Aye.

Smith - Aye.

Lober – Any opposed?

Isnardi - Nay.

Tobia – Nay.

Lober - Alright. Passes 3:2, with Commissioners Tobia and Isnardi in the negative.

Isnardi – And, but, we have five million dollars now for our Districts. So, I'll just say right now that I want my \$5 million to go to.

Tobia – Frank didn't do anything. Frank didn't do anything.

Ellis – Okay.

Isnardi - Public safety

Ellis - You can't do what you just did.

Lober - Why?

Ellis – It's not your \$5 million, or your \$5 million, or your \$5 million. That \$5 million does not belong to anybody that's at this Board. Now, you're welcome to go home, make a \$5 million dollar wish list, and bring it back to the Board to approve. And then I don't care, if you vote 5:0 and you approve everybody's wish list, more power to you. But none of you are empowered to pick out \$5 million bucks worth of expenditures on your own.

Lober – Shannon, is the Board able to delegate that authority?

Wilson – The Board has the ability to delegate authority to an individual Commissioner to make decisions of this nature.

Lober - I appreciate it.

Ellis - Without Board approval?

Wilson - They just.

Ellis – Afterwards.

Wilson - They just gave Board approval to do that.

Ellis – Okay. Well, we'll just see you in court.

Wilson - And, But, The.

Ellis – Nah. I promise you, we will see you in court on this one because all I see is a 25 million dollar slush fund.

Ellis – Alright, even when beach and riverfront. And you were here for that and Eden, you were here for that, that still had to come before the Board when they did the individual slush funds on beach and riverfront, and we finally got rid of that in the early 90's.

Wilson – Well, they have stipulated that it has to be COVID related, and it has to be approved by Tetra Tech as low-risk. So, I appreciate your difference.

Ellis – I mean, you can approve whatever. You should not delegate that down to individual Commissioners.

Lober - Shannon, let me ask you.

Ellis – To have the ability to spend that money.

Lober – Mr. Ellis, and again I appreciate your viewpoint. Um, we've got legal counsel here. I've got to go with the counsel that we have, who I've been satisfied with.

Ellis – That's fine. Look, we're used to being in court with you, Bryan, so, it's no big deal, and we'll be back in court again because you are not going to have five million dollar slush funds for every single Commissioner in this room.

Lober - Scott.

Ellis – To spend as you choose.

Lober: If I may respectfully suggest that you at least wait until you see where the allocations go, because it may be something that's totally wholesome that you have no objection to.

Ellis – If it's totally wholesome, then you all should vote on as a Board and you don't need to do it this way. You are. You are easily able, to each one of you come up with your five million dollar wish lists, walk into here as a Board, each present their five million dollars, and vote as a Board to approve all five of those wish lists.

Lober – I don't disagree, but that's not what the Board chose to do.

Ellis – Okay, with what you are doing is enticing to corruption when you have the ability to spend \$5 million as you choose. As you choose, you choose, you choose. Not you as a Board choose.

Lober: I'll put this out there to that end, anyone that reaches out to me asking for funds from this point on is going to have a, not a leg up but a leg down in terms of their likelihood of receiving them. I'm going to reach out to the organizations or the entities that I think need the money. So, as far as the suggestion there's some enticement for corruption, I'm, I'm just, I'm not interested in that.

Pritchett - Can I?

Ellis – Well, I don't know if you're interested in it or not.

Lober - I'm just telling you that I'm not.

Ellis – I didn't hear the former Clerk come up here and say he wasn't interested in corruption either until he got there, and had the ability to spend the money as he chose.

Lober - Commissioner Pritchett.

Pritchett – Can I? Let. Let's just try this, I really know what we're trying to achieve. Let me try three motions and see if this works, and this could probably settle.

Ellis – I understand what you're trying to achieve also, Commissioner.

Pritchett - I know. So.

Lober – Well, tell me what you're thinking before we undo things.

Pritchett - I'm going to make a motion to give \$5 million to Health First, a motion to give \$5 million to Parrish, and a motion to give \$5 million to the Port. And that's what we've been trying to do. I think that would, would solve.

Ellis – Yes, because then you vote as a Board for what you want to do.

Pritchett: And then and we'll just we'll just put on our big girl britches or big boy pants and we'll just do this.

Ellis - Or its.

Pritchett – And get it done because we know that's where we're wanting to allocate it and you can do.

Isnardi - This is like a circus.

Ellis – It's extremely dangerous to have anybody with the power to spend \$5 million as they choose of public money.

Isnardi – I don't know why you're looking at me.

Pritchett – Okay, and so then I want to make a motion to give five million dollars to Health First.

Lober - Well. Well, my concern, Commissioner.

Isnardi - And I have to abstain from that.

Pritchett - You do.

Isnardi – So, I'm going on the record.

Pritchett – You do.

Isnardi – That I'm filling out a form.

Lober – My concern since we've already, we've already delegated \$5 million apiece, if that passes.

Pritchett – I will pull that back.

Lober – But we've got to have a motion to reconsider that.

Pritchett – Okay. I want to make a motion to reconsider.

Smith - Or rescind that vote. Just rescind.

Lober – Okay, that's fine. That's you motion?

Pritchett – I make a motion to rescind that vote.

Lober – I'll second that motion.

Pritchett - Okay.

Lober - All in favor of rescinding the vote authorizing each of us and delegating the authority to spend up to \$5 million apiece, say Aye. Aye.

Pritchett - Aye.

Smith - Aye.

Isnardi - Aye.

Tobia – Aye.

Lober - Any opposed? Passes unanimously. All right let's.

Pritchett – Okay. I'd like to make a motion to give five million dollars to Health First.

Lober – Have we not already had that motion?

Wilson – Commissioner, could we amend that to um COVID related and uh approved by Tetra Tech.

Pritchett - Yes ma'am.

Lober – Before we do that is there not a prohibition in Robert's Rules on having the same exact motion heard the second time during the same meeting?

Smith – This is going to be combined. This is going to be a combined motion.

Tobia – (Unclear).

Pritchett - We don't seem to hit Robert's Rules at all.

Isnardi – Right, thank you.

Lober – Ms. Bentley, I don't think we've ever in my tenure had the same motion come up twice.

Pritchett – We just did it the other night to Curt and he approved it after he denied it once. So.

Lober – Well, we actually had different individual motions. We've trifurcated something as I recall.

Pritchett – Okay, I make a motion to give four million, 999.

Lober – Oh, that's a way around it.

Pritchett - Thousand dollars to Health First.

Tobia - I like it.

Lober - That's creative, I like it.

Isnardi – And I just want to go on the record because I have to abstain.

Pritchett – Yes. A second?

Lober – We'll see that as being a standing objection, Commissioner Isnardi.

Isnardi – I have to say it for every motion.

Wilson - Subject to being COVID related and vetted by Tetra Tech.

Pritchett - Yes.

Smith - Second.

Lober – All right we have a second from Commission Smith, as to Commissioner Pritchett's motion. Any discussion on it? I'll Call the Question. All in favor say Aye.

Pritchett - Aye.

Smith - Aye.

Lober - All opposed say Nay. Nay.

Tobia – Nay.

Lober - Fails 2:2.

Smith – Well then we're going nowhere.

Tobia – Need to try another one. (Unclear)

Lober – You want to try Parrish?

Pritchett – It's not going to pass. That's what we had we had everybody having their thing, but we all knew there were good things to do,

Lober - So.

Pritchett – And if we have the \$5 million we're going to do it anyways.

Isnardi – This is like a. This is like a circus.

Lober – Well, we really kind of need to figure it out. If you want to go back to the \$5 million motion we can do that again. I'll support that again. And I think we can all find respect.

Find Huar respective Courses.

Smith - Well, why not make a motion with all three in the same motion?

Lober – I'll vote against it. I'm just telling you. Anything that includes that allocation to Health First, I'll vote against.

Smith - How do you really feel?

Lober – I just don't want you to waste your time on it. I mean, if you have the votes otherwise by all means.

Smith - Well and you can't.

Isnardi – No.

Smith – Because it would be included. Health First would be included with Parrish and the Port, you can't vote on it.

Lober - Commissioner, respectfully, it ain't gonna happen today.

Smith - Okay.

Isnardi – And that's okay, because one will suffer because of another's.

Smith - Right. Exactly. So. Well. All, all three suffer.

Isnardi - Yeah.

Pritchett – I'm sorry, I make a motion for each Commission to have five million dollars that, that's appropriate for COVID funds to spend on appropriate projects.

Lober - Low Risk?

Pritchett – Yes. Sir.

Lober - I'll go ahead and second that, again. I'll Call the Question. This is certainly almost comical.

Smith - Yes.

Lober - All in favor say Aye. Aye.

Pritchett – Aye.

Smith - Aye.

Lober - Any opposed?

Isnardi - Nay.

Tobia - Nay.

Lober – All right. Passes 3:2, with Commissioners Tobia and Isnardi in the negative.

Isnardi – But now we're forced to have.

Tobia - Mr. Chair.

Isnardi - Five million dollars in our Districts, so.

Lober: Sir. Commissioner Tobia, Sir.

Tobia – Thank you. On my five, so, we can put it on the table, my \$5 million will be going to that public service.

Wilson – Public Safety.

Lober - Public Safety.

Tobia - Public Safety.

Abbate – Yeah, fund we're going to create.

Tobia – Fund, so add the \$5 million, that way it'll serve Countywide.

Isnardi – Okay, so, I want to make a motion that Commission Tobia's District 3 five million dollars and Commissioner Isnardi's \$5 million that was allocated in the previous motion go toward the Public Safety Fund. Does that sound correct?

Tobia: No. No, we don't. We don't. You don't need to.

Lober - You don't need a motion for that.

Tobia – Do this individually.

Lober - You can just do it.

Tobia - It's your \$5 million.

Isnardi - Oh, Jesus.

Tobia – So just throw it in the pot.

Lober – Do you need an additional motion to authorize either?

Isnardi – I feel like.

Lober – The Chair to sign any docs or to authorize the County Manager to sign any docs necessary to effectuate that action, Ms. Bentley?

Bentley – It's already in the. You have already made that motion.

Lober - Okay. I'm sorry, it's becoming a long day. I apologize.

Tobia – It's all good.

Pritchett – And. And, we can make a motion I'm putting mine towards Parrish hospital so you guys know right now.

Lober – No. No motion needed.

Pritchett – Okay.

Lober – But I think it's an excellent expenditure. All right? Perfect. And as I said with respect to mine, I want to mull over this and not do this impulsively although I think that was not at all an impulsive decision with respect to where that went or your decisions, with respect to where that went. I think those have all been excellent decisions in my opinion. But I do want to think it over. And as I said, if someone reaches out to me seeking funds for this, uh, partially for the reasons that Mr. Ellis identified. I'm not going to view that very favorably. So, I do want to do some research on my own and determine where I think it's going to generate the most benefit for the County.

Tobia – Mr. Chair.

Lober - Sir.

Tobia – What you thinking Commissioner Smith?

Smith – I think we're all crazy.

Tobia – Well, yeah, that by, by, by, uh virtue of being here, but where are you going to spend your \$5 million, Sir? Got any ideas? Tease us a little bit, Sir.

Smith - Um.

Lober – Well we've got half an hour until the Zoning meeting, so.

Smith - Yeah. I'll, I'll think on it.

Tobia – Okay.

Smith - Five million bucks all of a sudden, that's.

Tobia – That's a lot of it that's a lot of coin.

Smith - Yeah.

Ivey – We need some ideas. Give them to me.

Lober - Don't call Sheriff. Naw, I'm teasing you, Sir. All right.

Isnardi – I think, we're going to give poor Frank a stroke over here.

Abbate – You did that a little while ago.

Lober – Yes, this has certainly been an interesting meeting. I'll say that. Um, anything further that we have to decide, Mr. Abbate, or Jill? What else do we need to look at?

Tobia – Mr. Chair. Well, do we need to create that public? Do we need to create the, the dollars that aren't expended to be put in that Public Safety?

Lober – Oh, I would love that to be a motion.

Hayes - Frank, we didn't do a motion on.

Lober - But, let's, let's just make sure we've covered all our bases first.

Tobia – Okay.

Lober – And then, I'm happy to allocate everything left over to that.

Pritchett – (Unclear)

Abbate - Right.

Lober – Okay. So, here's, here's my request with respect to that, if Commissioner Pritchett, if you'd be so kind.

Pritchett – So moved.

Smith - Second.

Lober - All right. Okay. So, can you hear the motion first before you second it?

Smith – Well, I know what it says.

Lober – So, it would be. Okay, you've seen it? So, I'll just read it for the public that have not had access to this uh, that was passed out during the meeting and given to the Clerks, uh, during the meeting here. In accordance with the memo that I provided the Board, uh, during the October 27 BoCC meeting authorized the County Manager, or his designee, to reimburse up to 11 million, one hundred and thirty-six thousand, three hundred and fifty-six dollars over and above the existing one million, two hundred and fifty-three thousand, five hundred and fifty-five dollars listed as already obligated in relation, uh, to approve Countywide EMS transport costs, for an aggregate total of 12 million, three hundred and eight-nine thousand, nine hundred eleven dollars. Uh, motion will allow the Chair to, uh, sign any documents necessary to effectuate this action. The motion also contemplates that funds to be reimbursed will not be deposited in the General Fund, they'll remain set aside under the deposit account or fund, in which the future use shall be restricted to Brevard county Fire Rescue expenses. So, that's your motion Commissioner Pritchett and that's your second, Commissioner Smith? All right, seeing nods from both. That's the motion. All in favor say Aye. Aye.

Pritchett – Ave.

Smith - Ave.

Isnardi - Aye.

Tobia – Ave.

Lober - Passes unanimously. Okay. We're back on track, Mr. Abbate.

Abbate - Oh, one additional item I just wanted to be clear on it.

Lober - Sure.

Abbate – Because it was in the PowerPoint and we did discuss it, and that is, you know, I indicated earlier on that we were partners with both Health First and Parrish, as it related to COVID testing.

Lober - Sure.

Abbate – And that the number that I had here was 44 thousand, but Health First is submitting additional dollars.

Lober – 1.1 million.

Abbate – We would put that in that obligated column that, basically, what was reimbursable for those testing. Um, we would, uh, uh, provide to them.

Lober - Was that not already authorized by prior Board action?

Abbate – Well, I just want to be sure in light of everything that everybody was comfortable with that.

Lober – I'm not looking to backtrack on any commitments the Board's made. I just wanted to be clear about that.

Abbate – I believe it's a commitment, but I just wanted to let you know that, that's how I would be proceeding.

Lober - Yeah, I, that's how I see it as well. I'm not looking to be unfair to any entity, I think that's appropriate.

Abbate - Thank you.

Lober- Any, any objection apart from Commissioner Isnardi? All right. Perfect. Okay, so any, any further items that you think we absolutely must discuss, Mr. Abbate?

Abbate - I think we've.

Lober – Ms. Hayes?

Abbate – You've done quite a bit.

Isnardi – Look at Frank.

Smith – We've beat the horse enough.

Lober – Okay, so with respect to the remaining funds, may I have a motion to allocate them to a Public Safety.

Pritchett – So moved.

Tobia - Second.

Lober – Fund. Perfect. All right. Motion from Commissioner Pritchett, second from Commissioner Tobia. All in favor, please say Aye. Aye.

Pritchett - Aye.

Smith - Aye.

Isnardi – Aye.

Tobia – Aye.
