Mayor Alfrey,

Thank you for your commitment to the City of Melbourne and its relationship to Brevard County. The Board of County Commissioners apologize that some members of the City Council of the City of Melbourne, and its staff, found the will of this Board regarding the Olde Eau Gallie Riverfront CRA as expressed during its Board meetings, discussions between staff, and phone conversations, to be ambiguous. This letter is meant to provide complete clarity on this issue.

The Board would NOT find acceptable ANY program incentivizing the construction of a hotel. While the City may wish to provide further assistance to the development of a hotel, it is the position of the Board that this would not be an appropriate expenditure of County tax dollars.

The Board of County Commissioners expect an interlocal agreement, that includes the terms previously discussed, ratified by the City of Melbourne by May 4th, 2021.
