The purpose of this Budget Change Request is to shift available funding in Operating Supplies into Other Conracted Services. Funding is available in Operating Supplies due to the ultilization of an alternative cover at the Central Disposal Facility. These funds will be shifted into Other Contracted Services to provide funding related to the increase in yard waste that has been brought in since the start of the fiscal year. The increased funding to Other Contracted Services will fund the hiring of temporary employeese that are necessary due to the inability to recruit/hire qualified Household Hazardous Waste personnel.
