A RESOLUTION TO ADOPT A TENTATIVE BUDGET PURSUANT TO CHAPTER 200, FLORIDA STATUTES, AUTHORIZING THE BOARD OF COUNTY COMMISSIONERS TO ADOPT THE TENTATIVE BUDGET FOR FISCAL YEAR 2020-2021

4. This Resolution shall take effect immediately upon its adoption.
