SUBJECT:

Permission to Reject Bid Received in Response to Bid #B-7-17-100/Sykes Creek Parkway Force Main Replacement

FISCAL IMPACT:

Funding in the amount of \$800,000 is budgeted in 4153 Fund, Cost Center 365310/6985217.

DEPT/OFFICE:

Central Services

REQUESTED ACTION:

Request the Board of County Commissioners authorize Purchasing Services to reject the sole bid submitted for Bid #B-7-17-100, Sykes Creek Parkway Force Main Replacement; authorize staff to solicit bids based on revised plans and specifications; and award to the lowest responsive bidder. It is further requested the Board authorize the Chairman to execute associated contracts and authorize budget change requests as needed.

SUMMARY EXPLANATION and BACKGROUND:

The Board approved the Sykes Creek Parkway Force Main Replacement on September 27, 2016 as part of Utility Services Department's Capital Improvements Program.

On August 24, 2017, an invitation to bid was sent to the list of Brevard County's Pre-qualified Underground Utility Contractors for FY 2017 CIP Projects. Only one (1) bid was received and opened on October 6, 2017.

Maxwell Contracting, Inc.'s bid was significantly higher than the Engineer's Opinion of Probable Cost for this work, which was \$725,000. Utilities Services will work with the engineer of record to revise specifications in order to reduce the overall cost to within the project budget.

Upon approval of this action Purchasing Services will solicit bids for revised plans and specifications; and award to the lowest, responsive bidder.
