SUBJECT:	APPROVAL TO AWARD EMS TRUST FUND GRANTS FOR 2016. FISCAL IMPACT: \$71,918.50
DEPT/OFFICE:	Fire Rescue

Requested Action:

Request approval to award EMS Trust funding to local EMS providers who have submitted grant applications. Funding for this request is provided to the County from the State Department of Health. It is also requested that all budget changes necessary for this process be approved by the County Manager.

Summary Explanation & Background:

Annually, the Board of County Commissioners receives grant funding from the Florida State Department of Health (DOH). The funds are to be used for the purposes of improving emergency medical services to the County's citizens (F.S.401.104). Local distribution of this funding is done so in accordance with the EMS ordinance (Code of Ordinances, Chapter 42). A local grant process is performed where various emergency medical entities submit grant applications.

Three (3) local fire departments are to receive funding including Brevard County Fire Rescue. The total amount of the grant funding to be dispersed is \$71,918.50, which represents an accumulation of annual grant monies.

Attached to this agenda item is a listing of each grant. Fire Rescue is requesting approval of these EMS Trust Awards for 2016.
