Second Renewal to Road Striping Contract (Thermoplastic and Reflective Pavement Marking)

This Second Renewal is made and entered into the date of last signature below, by and between Brevard County, Florida, a political subdivision of the State of Florida (hereinafter referred to as "County"), and Florida Striping, Inc., a Florida Profit Corporation licensed to do business in the State of Florida (hereinafter referred to as "Contractor").

Witnesseth:

Whereas, the County has previously entered into an agreement with Contractor executed November 5, 2020, under Contract Number 5003 for the road striping services, specifically thermoplastic and reflective pavement marking (hereinafter referred to as "Original Contract"), which is incorporated herein by this reference; and

Whereas, the initial term of the Original Contract is three years after its date of execution and, subject to the County's sole discretion, the Contract may be renewed by the County in one-year increments for up to two additional years beyond the initial term of the Contract by providing prior written notice to the Contractor; and

Whereas, Compensation for Work shall be in accordance with Attachment A: Schedule of Unit Prices of the Original Contract, and the compensation schedule may be adjusted after the third year of the Original Contract upon mutual consent of the parties. Compensation adjustment shall be based on material cost variation or other relevant economic conditions, sufficiently documented by the requesting party; and

Whereas, the Contractor requested an increase in unit pricing prior to the third year of the Original Contract due to economic conditions, COVID-19, and availability of materials and labor; and

Whereas, Amendment 1 to the Original Contract was executed by the parties on November 9, 2021, and amended Section 4 of the Original Agreement granting a temporary adjusted compensation schedule for six (6) months; and

Whereas, the Contractor requested the temporary adjusted compensation schedule be extended for the duration of the initial term to the end of the first renewal period of the Original Contract based on the continued economic conditions; and

Whereas, the parties entered into the first renewal extending the Original Contract through November 4, 2024; and

Whereas, the Contractor requested the temporary adjusted compensation be extended through the second renewal period due to continued economic conditions; and

Whereas, this is the second, and final, renewal of the Original Contract and the parties hereto desire to renew the term of the Original Contract for an additional period of one (1) year continuing through November 4, 2025; and

Whereas, the parties hereto desire to enter into this Agreement in order to incorporate into the Original Contract the prior adjusted compensation schedule that shall be effective continuing through to the end of the first renewal period of the Original Contract, which is November 4, 2025.

Now, therefore, in consideration of the premises and mutual covenants contained herein, the parties agree as follows:

1. Recitals. The above recitals are true and correct and are incorporated into this Agreement by this reference.
2. Attachment A: Schedule of Unit Prices shall remain in effect continuing through November 4, 2025, attached hereto as Attachment A: Revised Schedule of Unit Prices.
3. Notice is hereby given to the Contractor by the County that the Original Contract, including the first renewal and other amendments or modifications made thereto, is hereby renewed pursuant to the notification provision set forth therein for an additional one (1) year, continuing through November 4, 2025.
4. All terms and conditions of the Original Contract, and any amendments or modifications made thereto, which are incorporated herein by this reference, that are not inconsistent with the provisions of this Agreement shall remain in full force and effect.

(hereinafter referred to as "Contractor").

Witnesseth:

Whereas, the County has previously entered into an agreement with Oglesby Construction, Inc., executed December 22, 2020, under Contract Number 5066 for the road striping services, specifically thermoplastic and reflective pavement marking (hereinafter referred to as "Original Contract"), which is incorporated herein by this reference; and

Whereas, the initial term of the Original Contract is three years after its date of execution and, subject to the County's sole discretion, the Contract may be renewed by the County in one-year increments for up to two additional years beyond the initial term of the Contract by providing prior written notice to the Contractor; and

Whereas, on November 9, 2021, the parties agreed to a temporary adjusted compensation schedule due to circumstances beyond the control of Oglesby Construction, Inc., including economic conditions, COVID-19, and availability of materials and labor; and

Whereas, on October 30, 2023, the parties entered into the First Renewal and agreed to extend the adjusted compensation schedule, which is attached hereto as Attachment A and incorporated herein by this reference, through December 21, 2024; and


