### **Fiscal Impact:**

This action will ensure that Brevard County continues to receive approximately \$10,474,000 in employment & training funds which assists in developing the workforce of Brevard to meet the talent pipeline needs for business and industry.

### **Requested Action:**

It is requested that the Brevard County Board of County Commissioners appoint the following to the CareerSource Brevard Board of Directors: Nuno Miguel Serraninho Mana. The term of the appointment are 3 years through June 30, 2025.

### **Summary Explanation and Background:**

The Brevard County Board of County Commissioners is required by Federal law to approve the appointments of members to the CareerSource Brevard Board (CSB). Board member requirements are outlined in the Federal Workforce Innovation and Opportunity Act of 2014, Florida Statute 445, CareerSource Brevard approved by-laws, the Grantee-Subgrantee Agreement with State Department of Economic Opportunity and CareerSource Florida Administrative Policy 91.

Business seats must include a C-level employee or business owner, a business with 5 or more employees, and a business that represents an in-demand industry within the region. The nominees have gone through a nomination and application process that includes a nomination from a local business organization such as, but not limited to, a Chamber, vetting through the CSB Executive Committee and the full CareerSource Brevard Board of Directors approval before it comes before the Brevard County Commission for final approval.

This appointment was approved by CareerSource Brevard's Board of Directors at the August 18, 2022, meeting. This appointment will assist in enhancing the overall goals of the mission of the organization by linking with another focused business within Brevard County.
