Pursuant to the provisions of Section 125.66, Florida Statutes, notice is hereby given that the Brevard County Board of County Commissioners shall hold a public hearing at 9:00 a.m. or as soon thereafter as the item may come up, on January 7, 2020, to consider the adoption of an ordinance creating a new article in Chapter 14, Article IV, entitled "Animal Abuse Registry", establishing the Brevard County Animal Abuse Registry, of the Brevard County Code of Ordinances, at the Commission Room, in Viera, Florida. The title of the Ordinance to be considered by the Board of County Commissioners of Brevard County, Florida, on that date reads as follows:

ORDINANCE NO. 20-_____

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA AMENDING CHAPTER 14 OF THE BREVARD COUNTY CODE OF ORDINANCES, "ANIMALS"; CREATING A NEW ARTICLE IN CHAPTER 14, ARTICLE IV, ENTITLED "ANIMAL ABUSE REGISTRY", ESTABLISHING THE BREVARD COUNTY ANIMAL ABUSE REGISTRY; PROVIDING FOR THE PURPOSE AND INTENT FOR THE REGISTRY; PROVIDING FOR DEFINITIONS; PROVIDING FOR THE ESTABLISHMENT AND REQUIREMENTS OF THE REGISTRY; PROVIDING FOR AN AREA ENCOMPASSED; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR CONFLICTING PROVISIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.
