AN ORDINANCE AMENDING ARTICLE III, CODE OF ORDINANCES OF BREVARD COUNTY, FLORIDA, AMENDING SECTION 2-73 PROVIDING FOR THE DEPARTMENTAL STRUCTURE OF COUNTY GOVERNMENT; PROVIDING FOR CONFLICTING PROVISIONS, SEVERABILITY AND AN EFFECTIVE DATE

Interested parties may appear at the September 19, 2017 meeting and be heard with respect to the proposed ordinance.

All persons for or against said ordinance can be heard at said time and place. If a person decides to appeal any decision made by the Board with respect to such hearing or meeting, he will need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is based.

The needs of hearing or visually impaired persons shall be met if the department sponsoring the meeting hearing is contacted at least 48 hours prior to the public meeting hearing by any person wishing assistance.
