Under the consent agenda, item 1 for Natural Resources, Change to Amendment 1 for time extensions of three City of Melbourne Save Our Indian River Lagoon Cost-Share Agreements, we were told by Tammy that the wording for Requested Action needs to be changed since it authorizes the county manager to execute but the contract extensions reviewed by the County Attorney have the Board Chair's signature. It should read:

It is requested the Board 1) execute time extensions for three City of Melbourne contracts, SOIRL 18-04, SOIRL 18-34, and SOIRL 18-35; 2) authorize the County Manager, or designee, to execute future amendments with fiscal impact less than \$100,000, subject to the approval of the County Attorney and Risk Management; and 3) approve associated budget change requests.
