HERBERT WILSON

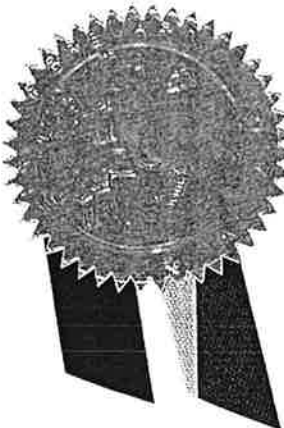
