WHEREAS, Mr. Karl Bohne, a distinguished member of the Florida BAR since 1988, represented the Town of Malabar with skill and professionalism.

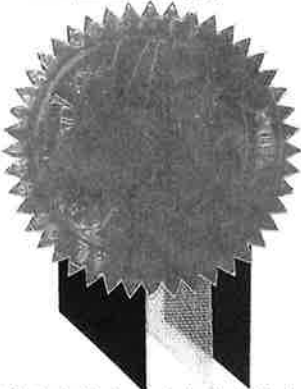
