D2's PROPOSED MOTION

While the County Attorney, County Manager, and I firmly believe that this motion is unnecessary to lawfully effectuate the following allocation authorizations and none of the preceding concede that this motion is required, in the interest of avoiding unnecessary litigation with the Clerk's Office (which would almost certainly result in substantial delay of numerous allocations), this motion is made to satisfy the Clerk's concerns so as to avoid any such litigation and, by extension, expedite the processing of checks on the part of County Finance which would otherwise linger during the pendency of an avoidable lawsuit.

This motion shall not be construed to limit authority granted in any prior motion.

The BoCC explicitly authorizes the expenditures indicated on the attached spreadsheet out of the \$5M delegated to District 2 County Commissioner Bryan A. Lober for allocation.

Many of the individual programs listed in the spreadsheet have already been discussed, to varying levels of detail, at duly noticed meetings of the BoCC.

The descriptions, within the spreadsheet, are not intended to be overly specific to permit adequate flexibility without necessitating bringing matters before the BoCC yet again for additional discussion prior to implementation. The spreadsheet is intended to provide a broad framework of unambiguously approved categories and funding amounts which the BoCC, as a whole, explicitly authorizes.

It is understood that staff will work with Commissioner Lober to implement these programs, within the broad framework provided, in a manner consistent with prior discussions on each such program.

Note: The individual amounts authorized, in aggregate, may exceed the \$5M delegated to District 2 for allocation. This is deliberate and is largely intended to allow for adequate flexibility should one or more programs and/or expenditures prove less costly than initially anticipated. In no event shall more than \$5M, in total, be expended from this funding source. For instance, if one program runs under budget (e.g., due to fewer applicants than anticipated seeking funding), the remaining funds may be shifted from that program to another program, up to that program's listed maximum authorization, without the matter necessitating additional BoCC approval or direction. In no event shall more than \$5M, in aggregate, be obligated or committed out of this pool of funding. Staff shall not transmit to County Finance requests to issue payment(s) once expenditures, from this funding source, totaling \$5M have been obligated or committed. Funding / cost / expenditure overages, within individual programs, shall be permitted, up to the indicated respective maximum values, in each listed program only to the extent that the \$5M aggregate funding cap is not exceeded.

Commissioner Lober is explicitly **authorized to reduce or eliminate funding** (which may viewed as deobligating funds from approved projects) from any authorized category prior to the time any such funds are obligated or committed. The terms *obligated* and *committed* shall be treated synonymously and shall serve to mean that such funds are contractually obligated such that the BoCC would be unable to lawfully refuse paying those funds without incurring liability for so doing.

Staff is authorized to draft and cause to be executed grant agreements for any expenses in which such agreements appear, in staff's opinion, appropriate (e.g., to obligate a funding recipient to purchase a vaccine freezer for which the recipient was paid in advance). Staff is additionally authorized to process any necessary budget change requests to accomplish the goals of this motion.
