

Approval, Re: Agreements between the Brevard County Board of County Commissioners, the City of Titusville, and Community of Hope, Inc. (District 1)

Fiscal Impact

Fiscal Year 2020-2021: There will be no fiscal impact to the General Fund. Funds are budgeted in the HOME Investment Partnerships Program grant Cost Center 1472-303052-- \$381,597.99

Fiscal Year 2021-2022: There will be no fiscal impact to the General Fund.

Requested Action:

It is requested that the Brevard County Board of County Commissioners authorize the County Manager or designee to (1) execute an agreement with Community of Hope, Inc.; (2) execute an Interlocal Cooperation Agreement (ILA) with the City of Titusville; (3) execute any future amendments or modifications upon approval by the County Attorney and Risk Management; and, (4) execute any necessary budget change requests.

Summary Explanation and Background:

A local, certified Community Housing Development Organization (CHDO), Community of Hope Inc. (CoH), submitted a request for funding to the Brevard County Affordable Housing Council (AHC) for an affordable housing project in the City of Titusville. In order to receive certification as a CHDO, the Brevard County Housing and Human Services Department must qualify the agency utilizing specific criteria per HUD guidelines. Some of the requirements include: (1) organization under State Law; (2) having as its purpose (in its Charter, Articles of Incorporation, By-Laws, or Resolution) the provision of decent housing that is affordable to low-income persons; (3) have a board of directors that is composed of one third low-income representation and no more than one third public representation; (4) have a minimum of one year of experience in serving the community where the project will take place; and, (5) must demonstrate the capacity of their key staff to carry out the proposed project.

The proposed project is a fourplex, which will consist of three units with three bedrooms and one bathroom and one unit (fully accessible to persons with disabilities) with two bedrooms and one bath. The units will be a minimum of 1,049 square feet with enhanced energy efficiency. Once complete, the units will be rented to persons whose income is at or below sixty percent of the area medium income of the Palm Bay-Melbourne-Titusville Metropolitan Statistical Area. For a family of three, their income cannot exceed \$37,380 a year. The units must remain affordable for 20 years.

The AHC has recommended approval of this joint project between the City of Titusville, the Brevard County

Board of County Commissioners, and CoH. The City will utilize Federal HOME-CHDO grant funds not to exceed \$305,578.52 and the County will utilize HOME-CHDO funds not to exceed \$381,597.99 for a total of \$687,176.51 which includes both hard and soft costs for the project. Construction cost per square foot for this project will be approximately \$114.58, which is \$0.70 per square foot above the national average per the International Code Council as of August 2020, and attributed to the enhanced energy efficiency upgrades.
