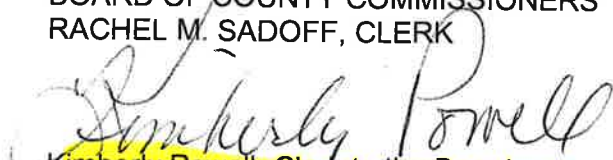
Re: Appointment to Charter Review Commission
