### Requested Action:

It is requested that the Board of County Commissioners approve and authorize the Chair to execute the attached Resolution and County Deed.

### Summary Explanation and Background:

The subject properties are located in Section 12, Township 28 South, Range 36 East, Section 1, Township 28 South, Range 36 E and Section 6, Township 28 South, Range 37 East, in the City of West Melbourne.

Public Works Department desires to convey ownership and maintenance to City of West Melbourne for: 1) the portion of Fell Road from the Max K. Rodes Park to Minton Road, 2) Meadowlane Avenue, and 3) Helen Street east of Minton Road. The City of West Melbourne desires to accept the transfer and as such applied for a conveyance of the transfer. It has been determined by the County that the transfer is in the best interest of the County and the property's use for roadway purposes will promote public health, safety or welfare; and will serve the public interest and a public purpose. The attached Resolution is pursuant to Section 125.38, Florida Statute authorizing the conveyance of County property. The attached County Deed will effectuate the transfer of ownership and maintenance to the City, together with associated drainage systems.

The User Department approves this request.

This acquisition follows the policies and procedures as set forth in Administrative Order 37.

"Party of the first part" and "party of the second part" are used for singular and plural, as the context requires and the use of any gender shall include all genders)

**WITNESSETH** that the party of the first part, for and in consideration of the sum of Ten Dollars, to it in hand paid by the party of the second part, receipt whereof is hereby acknowledged, has granted, bargained and sold to the party of the second part, its successors and assigns forever, any interest it holds in the following described land lying and being in Brevard County, Florida, to wit:

See Exhibit "A" and "B" attached and incorporated by this reference, together with all riparian and littoral rights appertaining thereto, and all interests in subsurface oil, gas, and minerals pursuant to section 270.11(3), Florida Statute. In the event the property is not used, maintained or ceases to be used and maintained for a public roadway with shoulders, swales and associated drainage appurtenances, the COUNTY does not retain any right to reenter and repossess the property.

**RESOLUTION NO. 21- 022**

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF  
BREVARD COUNTY, FLORIDA, PURSUANT TO SECTION 125.38, FLORIDA  
STATUTES, AND SECTION 2-247, BREVARD COUNTY CODE OF  
ORDINANCES, AUTHORIZING CONVEYANCE OF COUNTY PROPERTY; AND  
PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, Brevard County, Florida, a political sub-division of the State of Florida (hereinafter the COUNTY) owns certain public road rights-of-ways within the City of West Melbourne, a municipality incorporated under the laws of Florida (hereinafter the CITY); and

**WHEREAS**, the rights-of-ways for said public roads are referred to as: 1) a portion of Fell Road between Max K. Rodes Park and Minton Road, 2) Meadowlane Avenue and 3) Helen Street east of Minton Road, which is further described in Exhibits "A" and "B"; and

**WHEREAS**, the County Deeds with attached Exhibit "A" and "B" will effectuate the transfer and maintenance to the City, together with associated drainage systems; and

**WHEREAS**, the CITY has applied for and agrees to accept the conveyance and maintenance of the three roads known as: 1) a portion of Fell Road between Max K. Rodes and Minton Road, 2) Meadowlane Avenue and 3) Helen Street east of Minton Road, which shall promote the community interest and welfare of the CITY; and

**WHEREAS**, the COUNTY agrees that the CITY's proposed use of the properties for roadway purposes will promote public health, safety or welfare, will serve the public interest and a public purpose; and the COUNTY has determined that said properties are not needed for COUNTY purposes, and desires to cooperate with and assist the CITY by conveying the properties.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Brevard County, Florida, that:

1. The foregoing recitals are true and correct and incorporated to this Resolution by this reference.
2. The road rights-of-way to be transferred are fully described at Exhibit "A" and Exhibit "B" which is attached and incorporated by this reference. The requested road transfers are located within the boundary of the CITY, and are not needed for COUNTY purposes.
3. The COUNTY finds the CITY has requested the conveyance and the CITY will use and maintain the conveyances as public roadways to provide safe and well-kept roadways for the community.
4. In the event the any of the conveyed roadways described in Exhibit "A" and Exhibit "B" are not used, maintained or cease to be used and maintained for a public roadway, the COUNTY does not retain any right to reenter and repossess the properties.


5. The COUNTY authorizes the Chair, Board of County Commissioners, to execute all necessary documents to convey 1) that portion of Fell Road between Max K. Rodes Park and Minton Road, 2) Meadowlane Avenue, and 3) Helen Avenue east of Minton Road as described in Exhibit "A" and Exhibit "B" to the City by County Deed at nominal consideration pursuant to the terms of the Interlocal.

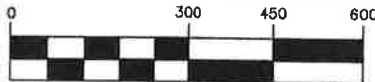

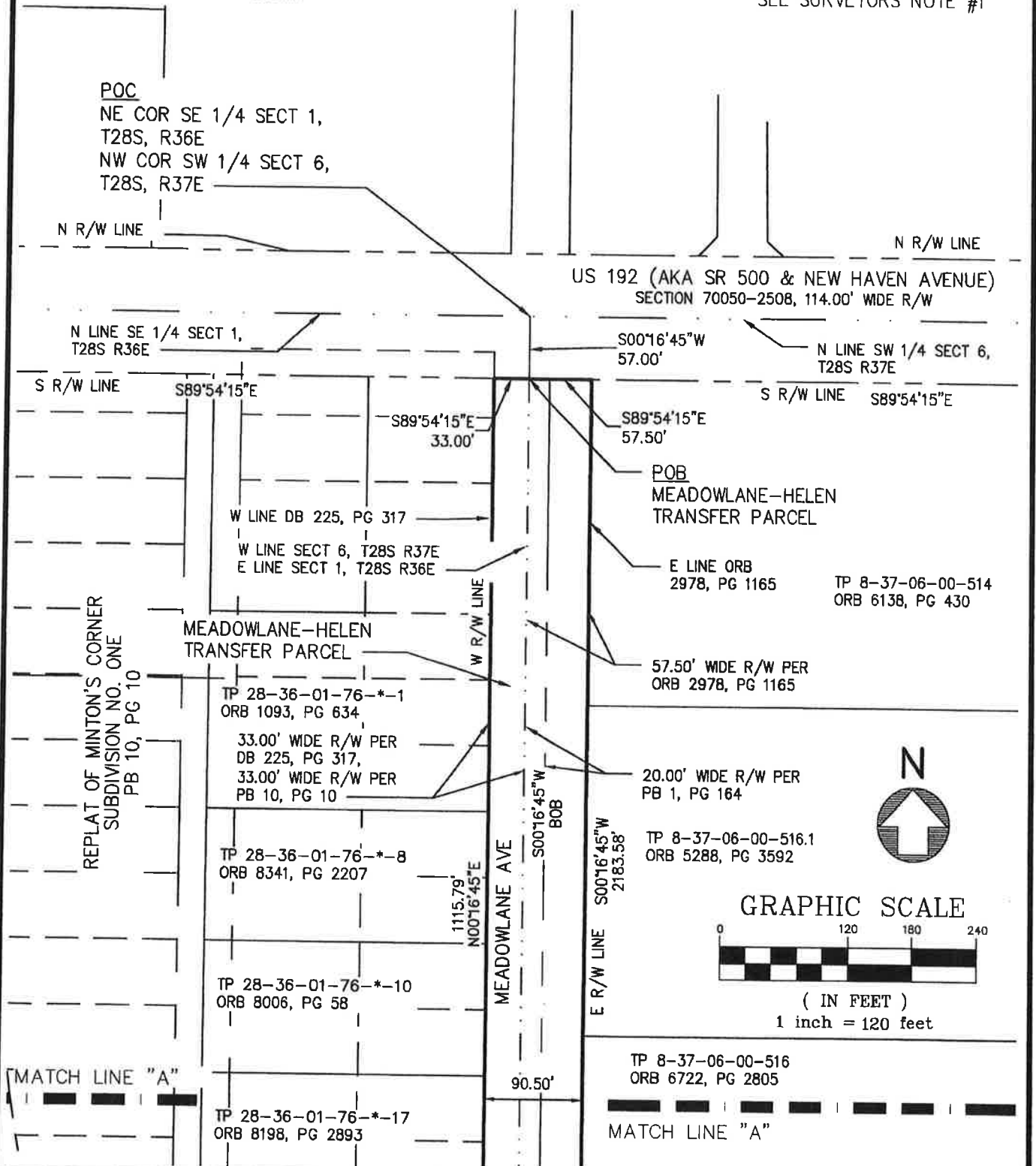

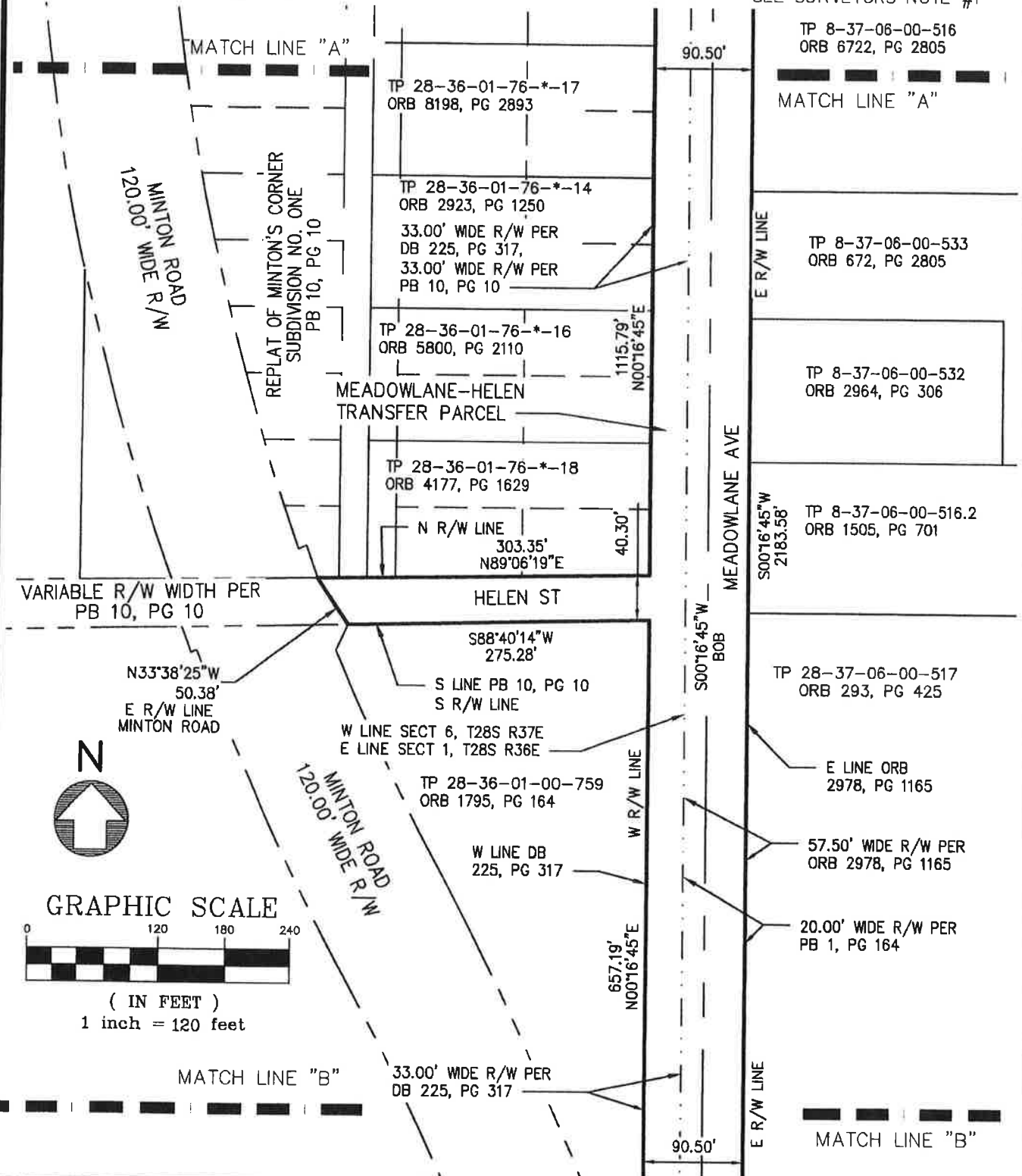
