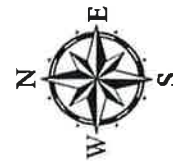
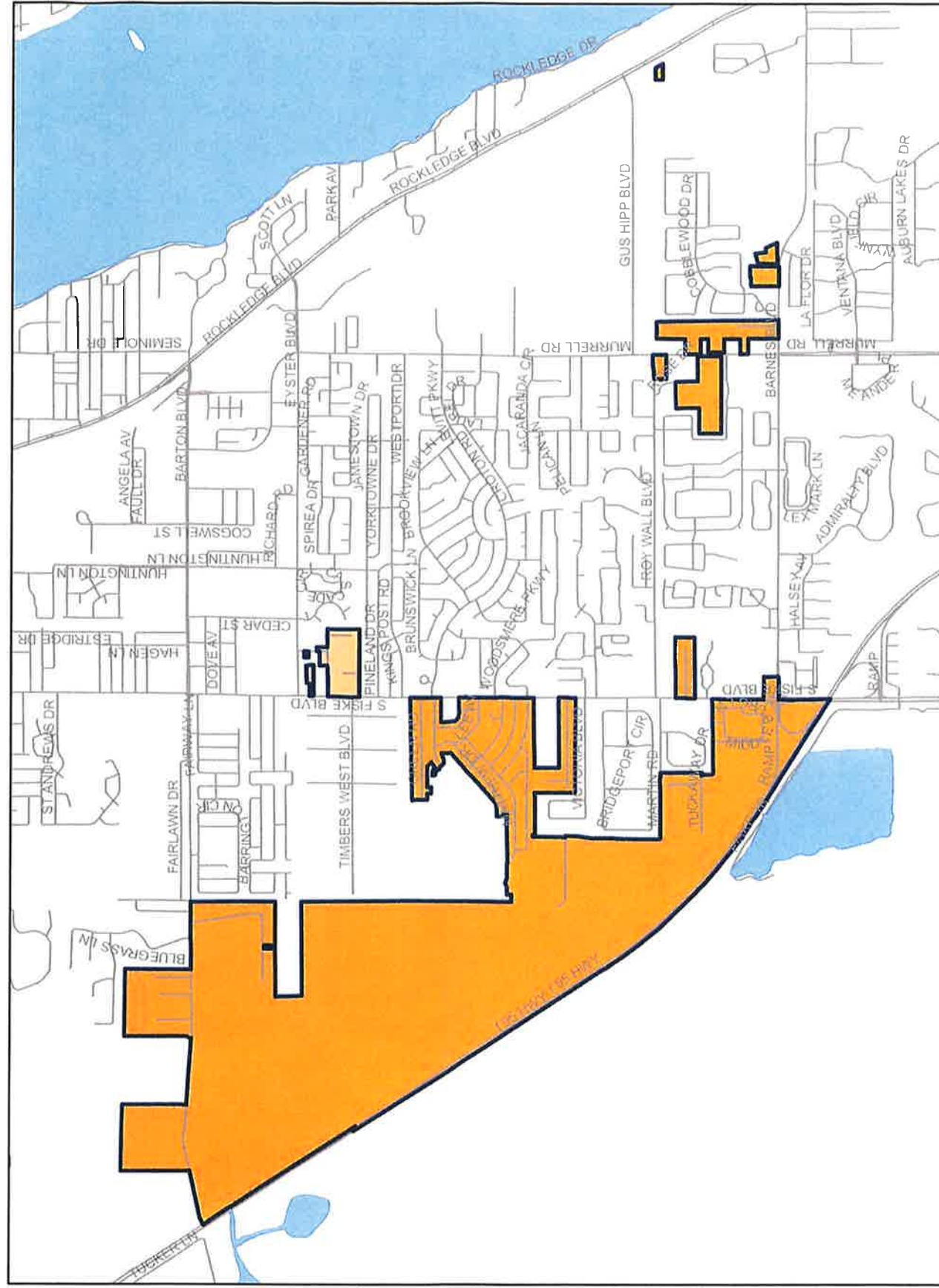




Description: Section of Precinct 222 was consolidated into Precinct 208

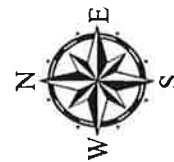
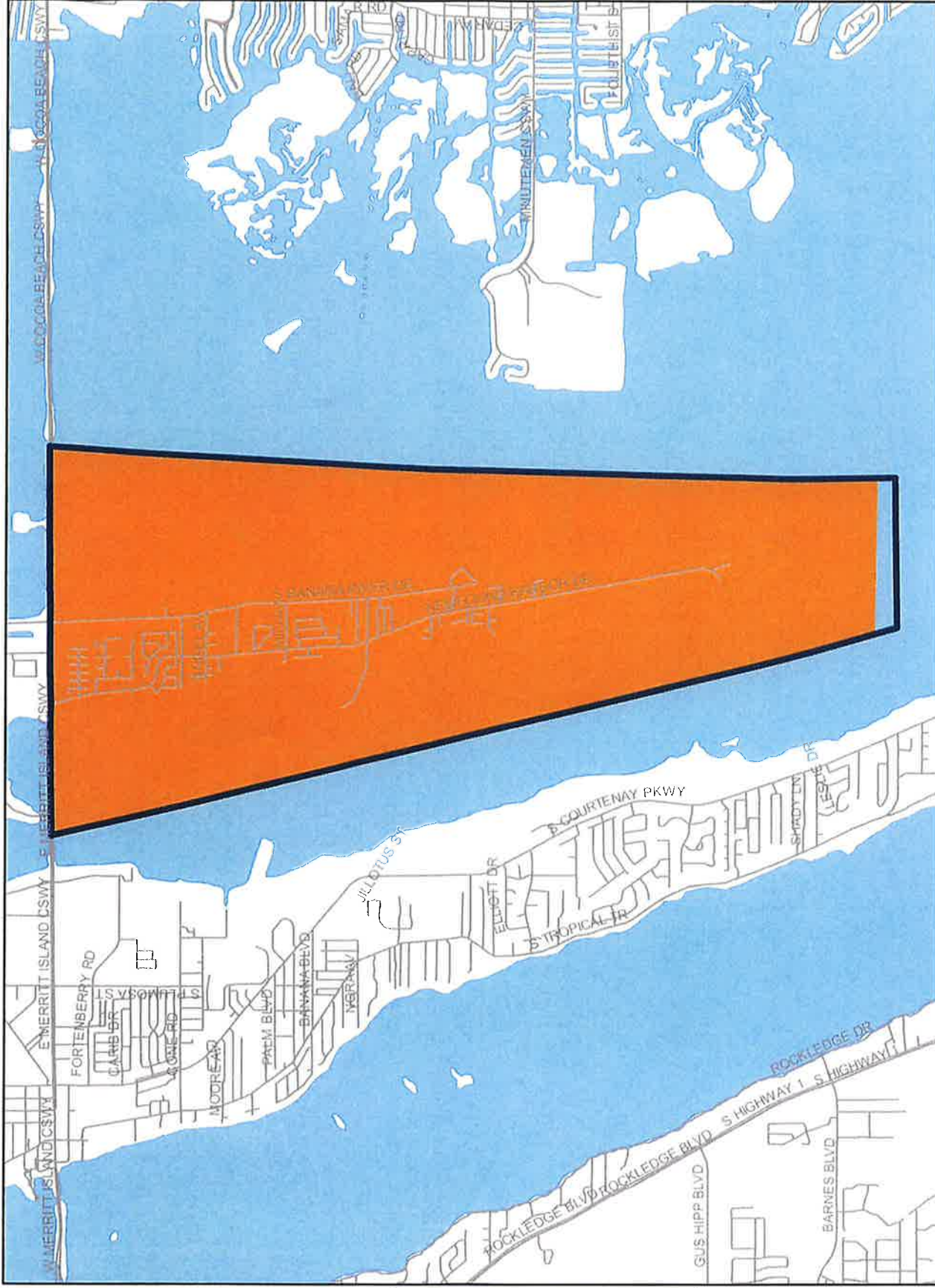


Description: Precinct 238 was consolidated into Precinct 228



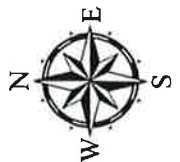
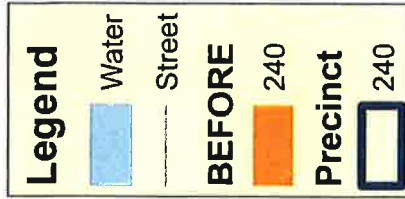
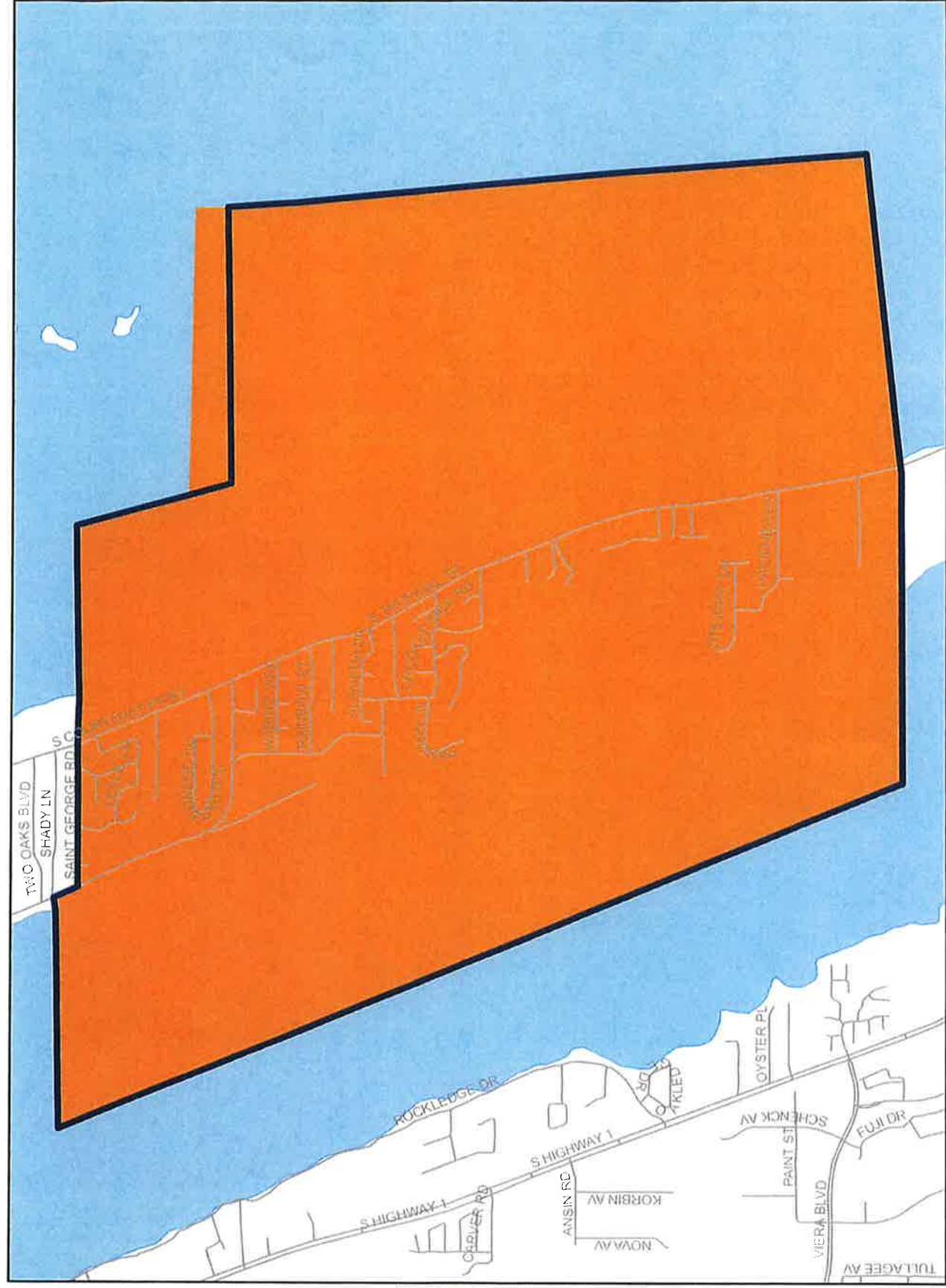

Description: Section of 240 was consolidated into Precinct 235



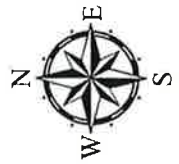
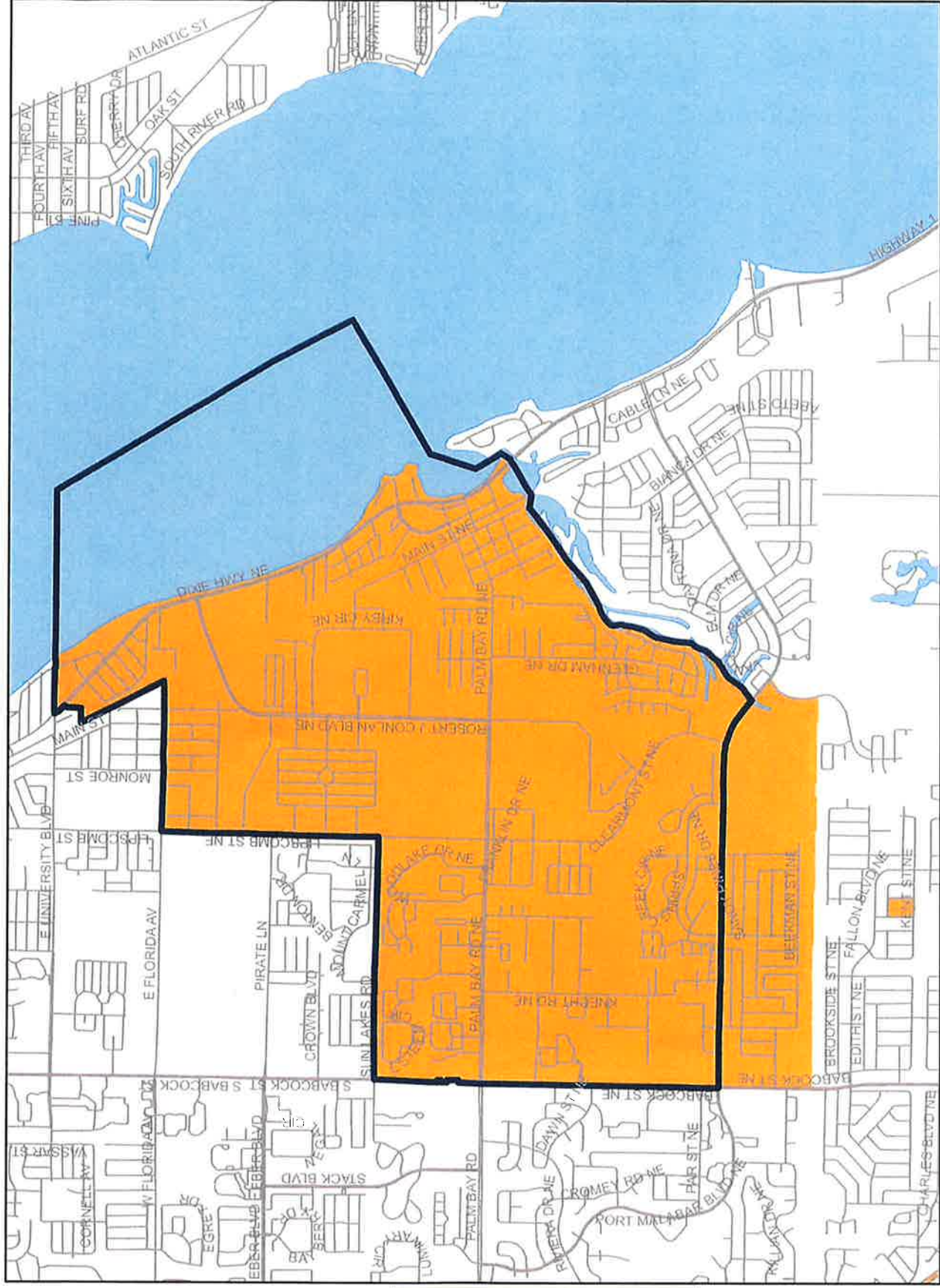

Description: Section of 240 was consolidated into Precinct 235



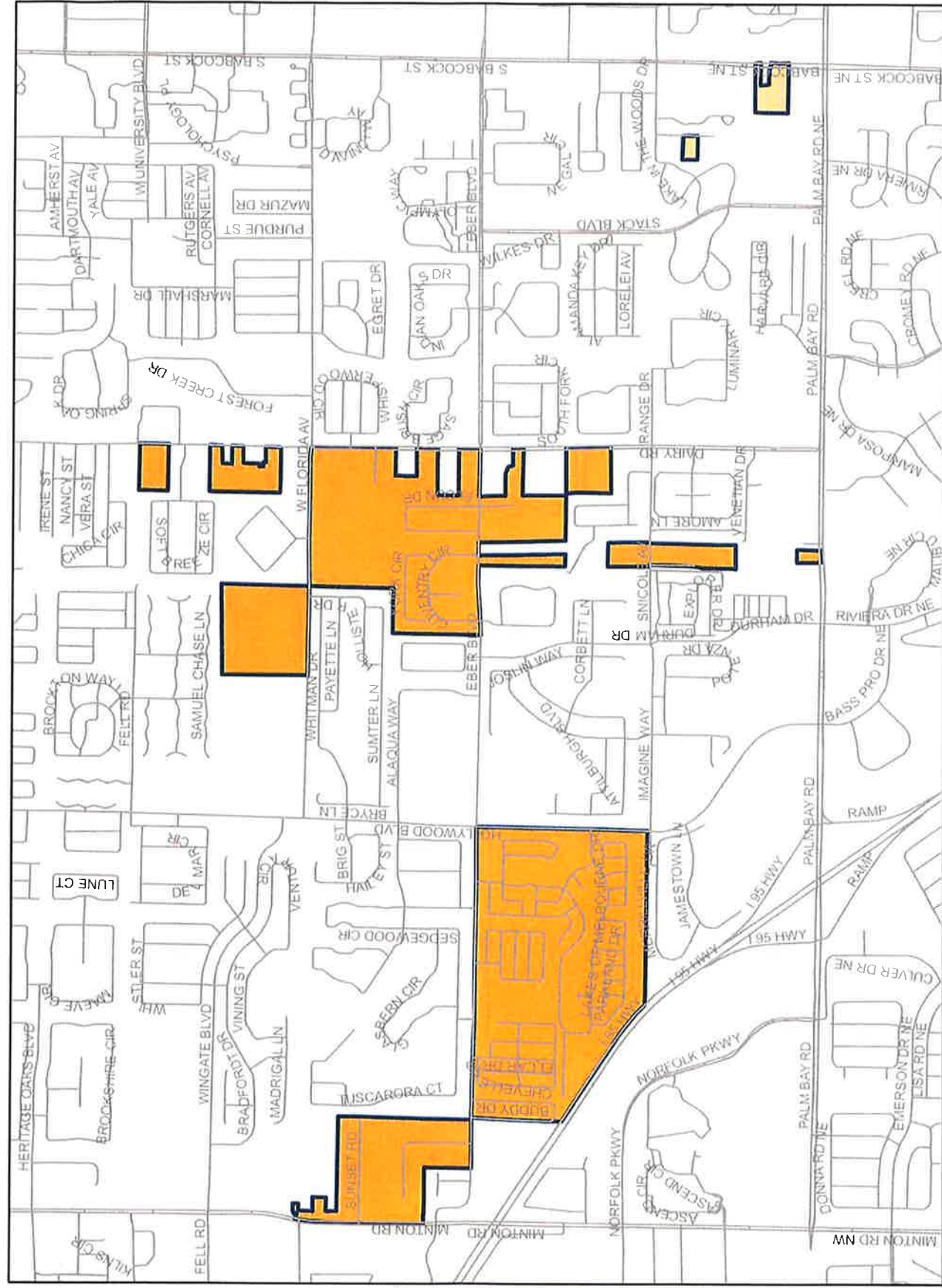

Description: Sections of Precinct 303 were consolidated into Precinct 314

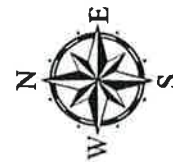
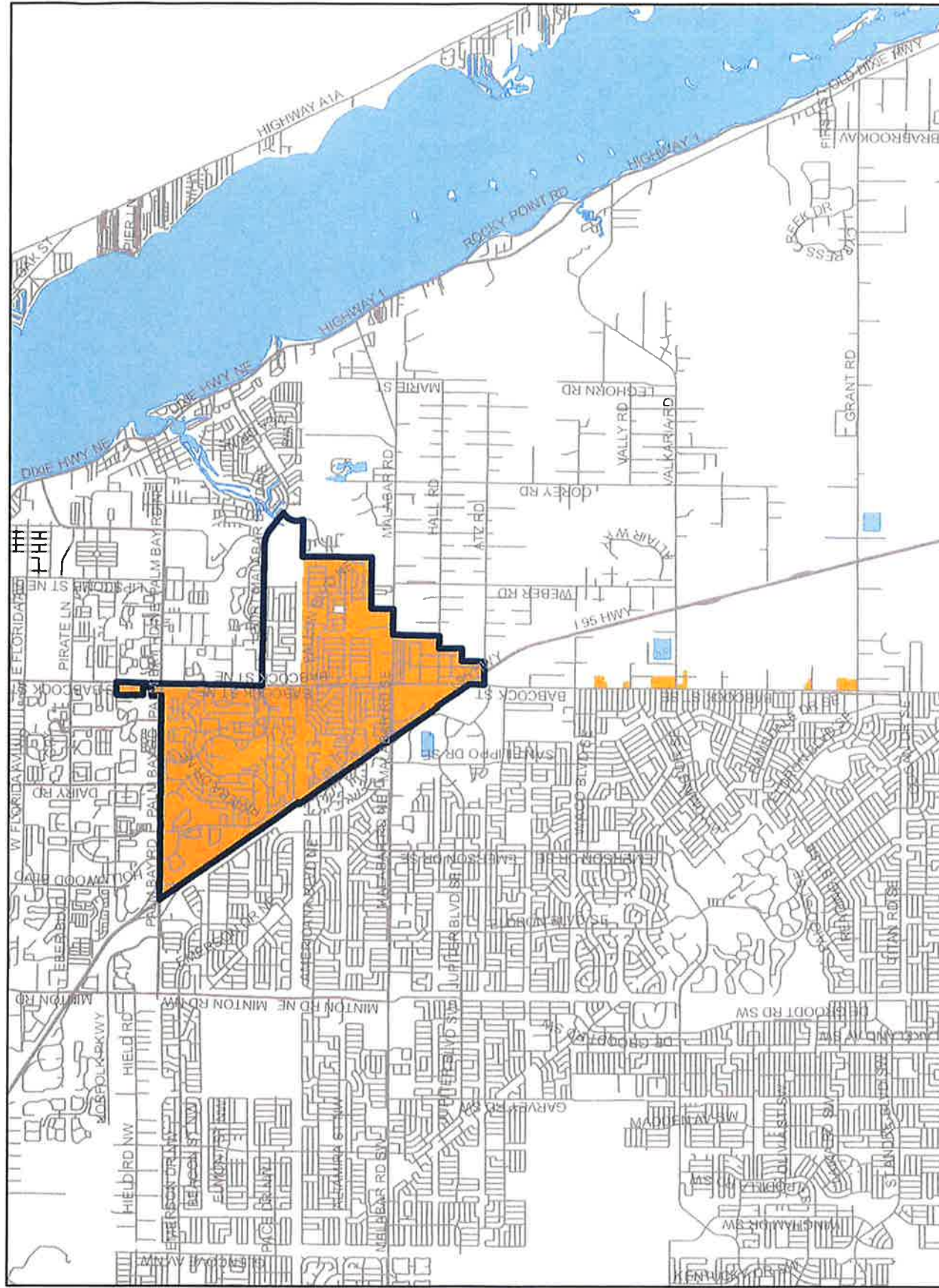

Description: Precinct 319 was consolidated into Precinct 307



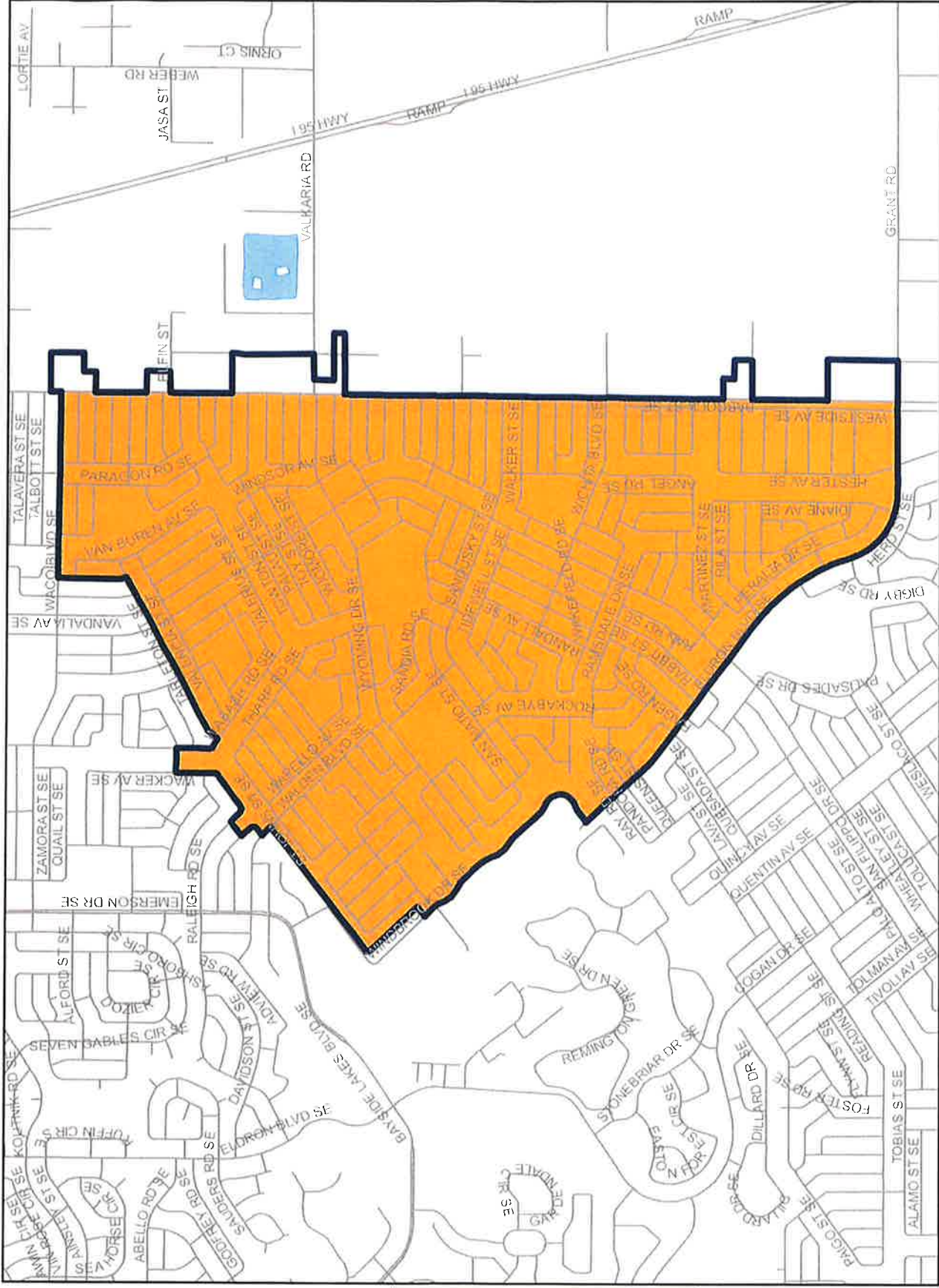

Description: Section of Precinct 418 was consolidated into Precinct 435



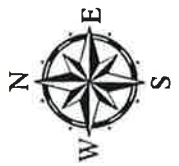
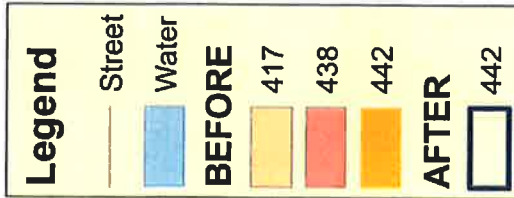
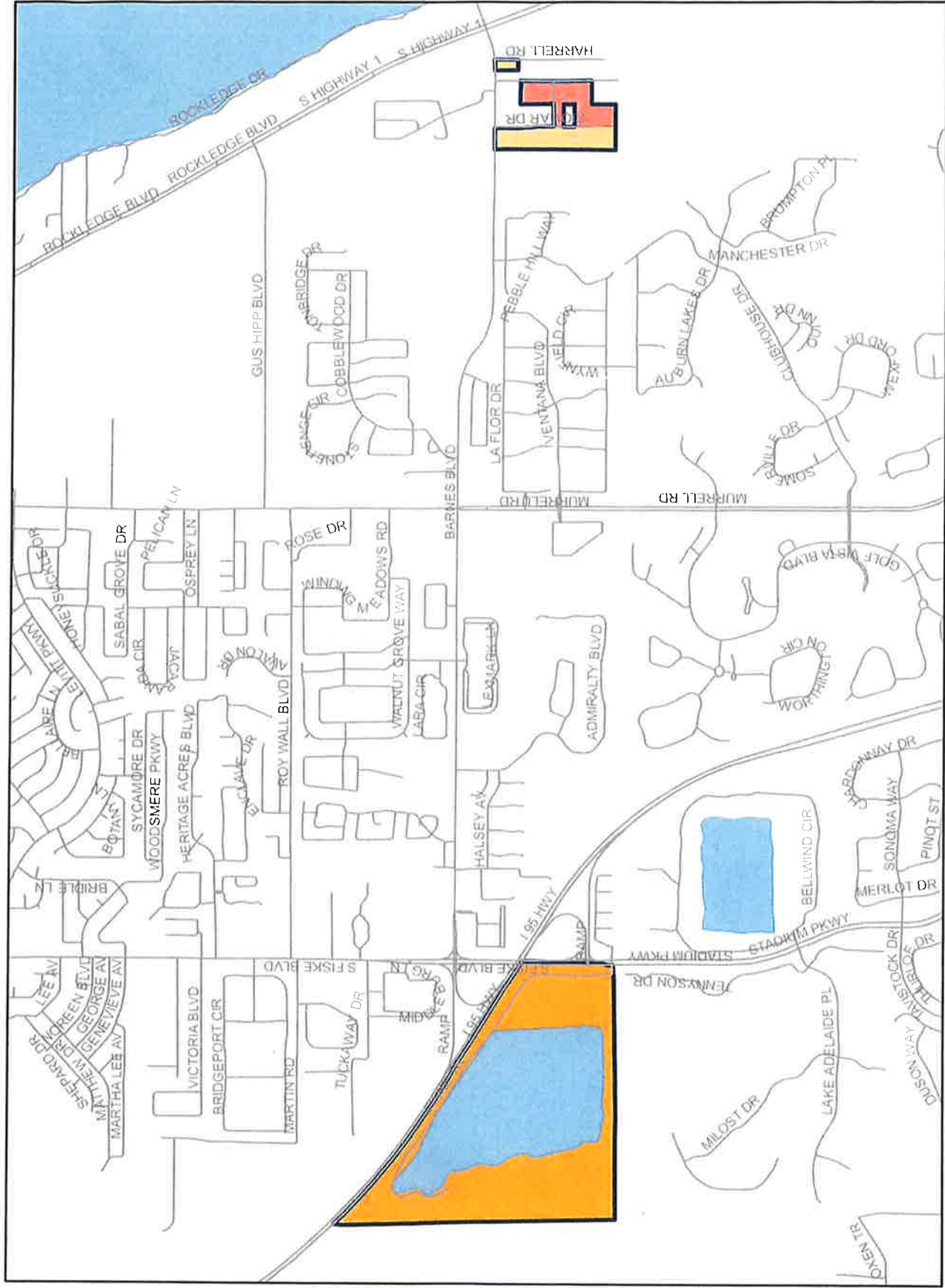
