### Subject:

Board Approval: Confirmation of Two (2) New Members to the County Emergency Medical Services Advisory Council

### Requested Action:

It is requested the Board approve the appointment of two new members to the County EMS Advisory Council, as per ordinance, to serve on the Council. The Board of County Commissioners must confirm appointments or reappointments of the membership for a two (2) year term beginning October 1, 2023, and ending on September 30, 2025.

### Summary Explanation and Background:

Per Article III, Section 42-88, Brevard County, Florida Code of Ordinances established by the County EMS Advisory Council (Council) to carry out such duties within the realm of emergency medical services as the Board and/or Fire Chief may delegate to the council from time to time. The members shall serve a two-year term and consist of seven (7) members from the following representation groups:

1. The County Fire Rescue Chief or designee; and
2. One (1) representative from each of the hospital systems located in the County; and
3. One (1) representative from a private-based emergency medical educator; and
4. One (1) representative from a public-based emergency medical educator; and
5. Three (3) representatives from the Space Coast Fire Chief's Association (SCFCA), representing the north, central and south county geographical areas.

The Council recommends the following appointments or reappointments to the membership for a two (2) year term and request confirmation of the membership by the Board:


