#### **Requested Action:**

It is requested that the Board identify those County Attorney applicants for Human Resources to conduct background and reference checks on in advance of future Board discussion and direction regarding which candidates to schedule for interviews.

## **Summary Explanation and Background:**

In accordance with direction previously provided by the Board, during the month of April Human Resources advertised for the upcoming County Attorney vacancy. By the close of the advertisement period, the County received 16 applications and resumes. Following Board direction, these applications were reviewed by Human Resources, the County Manager and the County Attorney. Separately, each arrived at the same list for our top 6 candidates. These candidates are identified for the Board's consideration in the attached exhibit. Also, as directed by the Board, all applications received in response to this advertisement have been provided to each County Commissioner for the Board's consideration and evaluation.

Human Resources will complete reference checks and background screening as directed by the Board and deliver the results to each Board member during June. Staff proposes that during the July 6th Board meeting, after Board members have had the opportunity to review the background information provided by Human Resources, the Board identify which applicants the Board would like scheduled for individual interviews. Human Resources is proposing to schedule individual candidate interviews with each Commissioner for all selected candidates on a single day, using multiple venues in the Viera Government Center. A round robin interview schedule would be established for a day convenient for all Board members during early July.

Subsequently, at the July 20<sup>th</sup> Board meeting, the Board can interview the candidates, select a candidate and direct who should conduct the contract negotiations with the successful candidate.
