At the City Council meeting held on April 15, 2015, the governing body of the City of Rockledge voted unanimously to withdraw from further consideration the name change for Pluckebaum Road. However, they did choose another road that has no addresses or structures at this time for renaming to honor Dr. Joe Lee Smith.

We realize that the County Commission had voted to support the name change of Pluckebaum Road. However, considering the impact to residents and to protect the legacy of the Pluckebaum family, the City Council felt it was in the best interest of the citizens to withdraw this from further consideration. Dr. Smith took the lead on this matter, asking that the City Council respectfully remove this from further action.

In order to be consistent, it is requested that the County Commission revoke the previous motion to change the name of Pluckebaum Road. Thank you in advance for your cooperation on this matter.
