Requested Action:

It is requested that the Board of County Commissioners approve and accept the attached Utility Easement.

Summary Explanation and Background:

The subject property is located in Section 23, Township 24 South, Range 36 East, on the north side of Mustang Way at Merritt Island High School in Merritt Island.

The Board of County Commissioners, in regular session on January 7, 2020, approved and accepted a Temporary Construction Easement from the School Board for the C01 Lift Station Rehabilitation Project. The Temporary Construction Easement (TCE) was required for construction activities related to the new force main from Lift Station C-01 due to some of the work being outside of the right-of-way and existing easements. The location of the proposed force main was dependent on the locations of existing utilities confirmed during construction activities. With the completion of the construction project, the actual location of the new force main is known and a permanent easement is required. The School Board has agreed to donate the needed easement.

This acquisition followed the policies and procedures as set forth in Administrative Order 37.

THIS INDENTURE, made this _//_ day of ______, 2021, between The School Board of Brevard County, Florida, whose address is 2700 Judge Fran Jamieson Way, Viera, Florida 32940, as the first party, and Brevard County, a political subdivision of the State of Florida, whose address is 2725 Judge Fran Jamieson Way, Viera, Florida 32940, as the second party, for the use and benefit of Brevard County, Florida.

WITNESSETH that the first party, in consideration of One Dollar (\$1.00) and other valuable consideration paid, the receipt of which is acknowledged, grants unto the second party, its successors and assigns, a perpetual easement commencing on the above date for the purposes of operating, constructing, reconstructing, reconfiguring, and maintaining public utilities and associated facilities and other allied uses pertaining thereto, over, under, upon, above, and through the following lands:

The land affected by the granting of the easement is located in Section 23, Township 24 South, Range 36 East, Brevard County, Florida, and being more particularly described as follows:


