<IT.6>AN ORDINANCE AMENDING THE BREVARD COUNTY CODE OF ORDINANCES, CHAPTER 14, ARTICLE II, ANIMAL CONTROL; PROVIDING FOR TRANSITION OF ANIMAL CONTROL AND ANIMAL SERVICES RESPONSIBILITIES FROM BREVARD COUNTY ANIMAL SERVICES AND ENFORCEMENT (BASE) TO AN APPOINTED ANIMAL CONTROL AUTHORITY; PROVIDING FOR AND AMENDING DEFINITIONS; PROVIDING FOR AND AMENDING PROHIBITED ACTS; PROVIDING FOR AND AMENDING ENFORCEMENT AND PENALTIES; PROVIDING FOR SEVERABILITY AND APPLICABILITY; PROVIDING FOR INCLUSION IN THE CODE OF ORDINANCES; AND PROVIDING FOR FILING AND AN EFFECTIVE DATE.<XI><NM>
