It is requested that the Board of County Commissioners accept and authorize the Chair to execute the Maintenance and Access Agreement.

SUMMARY EXPLANATION and BACKGROUND:

The subject parcel is located in Section 13, Township 26, Range 36.

The Public Works Department, Road and Bridge Section, is planning a drainage improvements project along the North, South and East perimeter ditch located in Tracts 4 and 5 of the Suntree Country Club subdivision to improve functionality of the drainage system. Pinehurst Avenue and Doral Lane are County maintained streets and drain onto Tracts 4 and 5 via a drainage easement. The project consists of cleaning and reshaping the perimeter ditch. The Maintenance and Access Agreement allows for additional drainage improvements that are needed outside the boundaries of the existing drainage easement. Upon completion of the construction project, the County and Owner wish to delineate maintenance responsibilities.

MAINTENANCE AND ACCESS AGREEMENT

THIS AGREEMENT, made and entered into this <u>30</u> day of <u>Savuary</u>, 2019 by and between BREVARD COUNTY BOARD OF COUNTY COMMISSIONERS, BREVARD COUNTY FLORIDA, a political subdivision of the State of Florida, hereinafter referred to as "County", and SUNTREE COUNTRY CLUB, INC., a Florida Not for Profit Corporation, who mailing address is One Country Club Drive, Melbourne, FL 32940 hereinafter referred to as "Owner".

WITNESSETH:

WHEREAS, the Owner owns that certain parcel of land referred to as Tracts 4 and 5, Suntree P.U.D. Stage One, Plat Book 24, Page 37; and

WHEREAS, Pinehurst Avenue and Doral Lane are County owned and maintained roads for the use of the public that have been subject to flooding and drainage issues; and

WHEREAS, Pinehurst Avenue and Doral Lane drain onto Tracts 4 and 5 via drainage easements; and

WHEREAS, the County has plans to improve drainage along the North, South and East perimeter ditch located in Tracts 4 and 5 as shown on the attached Exhibit A for the purpose of improving drainage along Pinehurst Avenue and Doral Lane; and

WHEREAS, additional drainage improvements are needed outside the boundaries of said drainage easements in certain areas of Tracts 4 and 5 to improve functionality of the drainage system; and

WHEREAS, County and Owner wish to delineate maintenance responsibilities after construction for improvements made by County.

NOW, THEREFORE, it is mutually agreed as follows:

- 1. The recitals set forth above are true and correct in all respects and are incorporated herein by reference as if set forth herein verbatim
- 2. The Owner will be responsible for routine maintenance of perimeter ditch system within Tracts 4 and 5 and any and all landscaping and sod associated with said perimeter ditch.
- 3. The Owner will maintain the perforated pipe system and underdrain system located within said perimeter ditch system.
- 4. The County on an as needed or emergency basis will maintain the positive flow of water in the perimeter ditch by clearing any blockages or impediments to drainage

and reshaping the perimeter ditch areas should washing out occur. The County will make all reasonable attempts to notify Owner manager or superintendent that County or its contractors will be on site conducting emergency maintenance of the perimeter ditch.

- 5. Owner hereby grants to County a perpetual right of access to maintain positive flow and for inspection of the perimeter ditch system.
- 6. In the event County determines sod shall need to be replaced after emergency or non-routine maintenance by the County to maintain positive flow of the perimeter ditch, the County will install the County's standard Bahia sod. If the Owner desires to upgrade from the standard County sod, the Owner agrees to pay the difference in costs as calculated by the County.
- 7. After execution by all parties, County will record this Agreement in the public records of Brevard County, Florida.
