NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Brevard County, Florida, on January 21, 2019 at 9:00 a.m., in the Commission Room at 2725 Judge Fran Jamieson Way, Building C, First Floor, Viera, FL, 32940, will hold a public hearing on the following ordinance:

### ORDINANCE NO. 20-\_\_

**AN ORDINANCE OF THE BREVARD COUNTY BOARD OF COUNTY COMMISSIONERS ESTABLISHING CAPITAL RECOVERY CHARGES FOR CONNECTION TO WASTEWATER COLLECTION AND TRANSMISSION FACILITIES, TO BE KNOWN AS THE NORTH MERRITT ISLAND TRANSMISSION SYSTEM – PHASE 2, PRESCRIBING THE BOUNDARIES OF SAID SYSTEM TO CONSIST OF CERTAIN PROPERTY CONTAINED WITHIN TOWNSHIP 23, RANGE 36, SECTIONS 25-27 and 34-36; AUTHORIZING THE COLLECTION OF CHARGES IN SUBSTANTIALLY THE SAME MANNER AS PROVIDED IN CHAPTER 67-1145, LAWS OF FLORIDA (1967); PRESCRIBING THE PROCEDURE FOR THE FIXING OF AN INITIAL SCHEDULE OF CAPITAL RECOVERY CHARGES FOR THE USE OF THE FACILITIES TO BE FURNISHED BY SAID SYSTEM; AND PROVIDING FOR AN EFFECTIVE DATE.**

All persons for or against said ordinance can be heard at said time and place. If a person decides to appeal any decision made by the Board with respect to such hearing or meeting, he will need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is based.

The needs of hearing or visually impaired persons shall be met if the department sponsoring the Public Hearing is contacted at least 48 hours prior to the public meeting hearing by any person wishing assistance. The sponsoring department is the Utility Services Department, 321-633-2091.
