It is requested that the Brevard County Board of County Commissioners consider and approve the County

Summary Explanation and Background:

On July 5, 2022, the Board appointed and approved a Negotiation Committee to approach and offer Cecil "Morris" Richardson the position of County Attorney.

On Friday, July 15, 2022, the Negotiation Committee and Mr. Richardson met and negotiated the terms of the County Attorney's Agreement for the Board's consideration and approval.

Negotiated terms in the County Attorney's Agreement include:

- The effective date of XXXXXXX XX, 2022.
- The annual salary of \$XXXXXXXXXX.
- County agrees to pay employee a lump sum severance cash payment equal to twenty (20) weeks of compensation if separation is for the convenience of the County.
- The employee's prior service with FRS employers shall be credited toward his years of service with Brevard County when determining annual and sick leave that he will receive from the County.

Dear Commissioners:

Please accept my application to be your next county attorney. Having served for over ten years in the Brevard County Attorney's Office, writing this letter feels like the first step on a journey home.

I am a proud product of Melbourne High School and the Florida Institute of Technology. After graduating from Vanderbilt Law School, I returned to Florida, where I worked in private practice for two of the most respected law firms in the state. While representing a client at a city council meeting one night, I became curious about life on the other side of the dais. That initial spark of interest grew into a passion for local government law. I joined the Brevard County Attorney's Office in 2005 and never looked back.

From the beginning, I was entrusted with some of the County's most significant litigation. I successfully represented the Board of County Commissioners in lawsuits in state and federal court, in administrative proceedings, and on appeal. At the request of the State Attorney's Office, I defended a County ordinance against constitutional challenges raised by criminal defendants.

In my ten years with Brevard County, I was assigned to almost every department, from Brevard County Fire Rescue to the Valkaria Airport. For much of my tenure, I was charged with attending the Board of County Commissioners' zoning meetings, where I provided legal advice and guidance directly to the commissioners. My other longtime board assignments included the Planning and Zoning Board, the Contractor Licensing Board, and the Merritt Island Redevelopment Agency Board of Directors.

The cross-training that I received as an assistant county attorney familiarized me with most aspects of Brevard County government. Having done almost every job in the County Attorney's Office, I will be able to hit the ground running and effectively direct and supervise the efforts of its dedicated professional and support staff.

I left the County Attorney's Office in 2015 to become the City Attorney for West Melbourne. As City Attorney, I report directly to the seven-member City Council. In addition to providing every legal service required by the City Council and administration, I attend every meeting of the City Council, Planning and Zoning Board, Board of Adjustment, and Code Enforcement Board.

I endeavor to cultivate comfortable, collaborative, and mutually respectful relationships with the elected officials I serve. It is my mission to further the policy objectives of the governing body, while working together with the elected officials and management team to find creative solutions to difficult problems.
