Approval RE: Transportation Impact Fee Technical Advisory Committee for the Central Mainland Benefit District Project Funding Recommendations (Districts 1, 2 and 4)

Fiscal Impact:

The Impact Fees that will fund the project recommendations have been collected in prior fiscal years. Collections from Impact Fees accumulate in Reserves for Capital Outlay until projects are identified and approved. They are then disbursed to the municipality where the impact fees were assessed. \$114,000 will be disbursed to Brevard County Public Works if approved.

Requested Action:

It is requested that the Board of County Commissioners consider approval of Brevard County Public Works project funding recommendation in the amount of \$114,000 as prepared by the Transportation Impact Fee Technical Advisory Committee for the Central Mainland Benefit District on August 2, 2023; and if approved, authorize the Budget Office to execute any budget change requests necessary for implementing these appropriations.

Summary Explanation and Background:

The Transportation Impact Fee Technical Advisory Committee for the Central Mainland Benefit District met on August 2, 2023 and unanimously adopted the project funding recommendations itemized below. The Transportation Impact Fee Technical Advisory Committee consists of representatives from the City of Cocoa, the City of Rockledge, the Town of Palm Shores, and Brevard County Public Works.

Project Funding Recommendations:

1) Appropriate \$114,000 for the survey, engineering design and construction of intersection improvements at the intersection of Viera Boulevard and Grand Isle Boulevard.

This intersection lacks an eastbound left turn lane despite the frequency of eastbound left-turning vehicles. In order to provide turn lane capacity, Brevard County Public Works will seek to widen the pavement along the median to construct a dedicated left turn lane. As a result, traffic flow and safety will improve along this segment of Viera Blvd.


