SUMMARY EXPLANATION and BACKGROUND:

Per Resolution 04/045, adopted by the Board of County Commissioners on February 24, 2004, and Florida Statute 197.3632(3)9a), the Board must annually ratify and certify to the Tax Collector the Municipal Services Benefit Unit Assessment Rolls. The Roll is maintained in an electronic format by the Property Appraiser's Office.

The Municipal Service Benefit Unit Program utilizes assessment revenue for the repayment of Commercial Paper that was used to fund the improvements projects. These improvements are in keeping with Brevard County's vision of enhancing the quality of life for its' citizens.

1. The Board of County Commissioners of Brevard County, Florida, hereby ratifies and confirms that the annual Municipal Service Benefit Unit Assessment Roll for County fiscal year beginning October 1, 2018, is in conformity with the Final Assessment Rolls for each project that have been adopted by the Board.
2. The Board of County of Commissioners of Brevard County, Florida, hereby certifies, ratifies and confirms such annual Municipal Service Benefit Assessment Rolls as sent to the Tax Collector. The Tax Collector shall collect such special assessments in the same manner as ad valorem taxes are collected.

3. A certified copy of this Resolution shall be delivered to the Tax Collector of Brevard County, Florida.
4. This Resolution shall take effect immediately upon adoption.
