D/B/A USSI GLOBAL; SPECIFYING THE ITEMS EXEMPTED; PROVIDING THE EXPIRATION DATE OF THE EXEMPTION; FINDING THAT THE BUSINESS MEETS THE REQUIREMENTS OF SECTION 196.1995, FLORIDA STATUTES; PROVIDING FOR PROOF OF ELIGIBILITY FOR EXEMPTION FOR NATIONAL SERVICE SOURCE, INC. D/B/A USSI GOLBAL; PROVIDING AN EFFECTIVE DATE.
