Requested Action:

Request that the Board of County Commissioners approve the reallocation of funds and subsequent budget adjustment of \$867,969 for FY23 purchase orders that were not received prior to 09/30/2023 as planned.

Summary Explanation and Background:

The Brevard County Sheriff's Office completed the fiscal year on September 30, 2023 and was required to close-out twenty-one (21) FY23 pending and allocated purchase orders totaling \$867,969. These purchase orders were created at various times throughout FY23 for law enforcement capital and operational purchases. However, due to continued issues within certain supply chains and the economic environment, these vendors were unable to produce and deliver the equipment as expected prior to September 30, 2023.

These purchase orders are not only needed for continued operations, but also represent contractual commitments with these suppliers and cancellation of the orders could result in a negative economic impact to the BCSO.

BCSO is respectfully requesting the reallocation of the FY23 funding totaling \$867,969 back to the BCSO FY24 budget. This will allow the funding of the reissued purchase orders and outstanding obligations to be met to ensure operational effectiveness.
