Approval Re: Conveyance of Barnes Boulevard from Fiske Boulevard to Cobblewood Drive to the City of Rockledge - District 4

## Requested Action:

It is requested that the Board of County Commissioners: 1) approve and authorize the Chair to execute the County Deed and Resolution, 2) approve and authorize the Chair to execute the Assignment of Easements and Resolution, 3) approve and authorize the Chair to execute a Drainage Easement, a Utility and Drainage Easement and Resolution, 4) approve and authorize the Chair to execute the Release of Temporary Construction Easements, and 5) authorize transfer of any associated permits.

## **Summary Explanation and Background:**

The Board of County Commissioners, in regular session on November 12, 2002, executed a revised Interlocal Agreement with the City of Rockledge for Barnes Boulevard Widening Project. Paragraph 10 of the Agreement states that the County and the City agree that upon completion of the construction project, the City will assume ownership and maintenance responsibilities of Barnes Boulevard from Murrell Road to Fiske Boulevard (including all retention/detention ponds and off-site acquisitions related to the project), two years after construction is complete. The construction of the project was completed September 14, 2018.

The St. John's River Water Management District (SJRWMD) permit for the West Pond Basin will also be transferred to the City and included as part of the transfer package. The limit of the permit has an east terminus at Cobblewood Drive which extends the limits agreed upon in the Interlocal Agreement east of Murrell Road by approximately 750 additional feet. The City staff recognize the benefit of obtaining sole ownership of the permit, and the County and City mutually agree on the transfer of the additional limits.

The Army Corps of Engineers permit will be transferred to the City and included as part of the transfer package as well.

The County Deed will convey Barnes Boulevard right of way from Fiske Boulevard past Murrell Road to the east terminus of the West Pond Basin at Cobblewood Drive, together with ownership, maintenance, and functional responsibility for Barnes Boulevard from the east terminus of the West Pond Basin at Cobblewood Drive to

Fiske Boulevard and its associated roadway, retention pond, drainage systems, the applicable permits, such as the SJRWMD and U.S. Army Corps of Engineers for the West Basin, as well as the traffic signals servicing the three signalized intersections at: 1) Henderson Way, 2) Three Meadows Drive, and 3) Murrell Road with their associated facilities and controllers. In the future, the County and City will amend the existing Interlocal Agreement for traffic signal maintenance and compensation to add these signals to the Agreement's inventory.

The Resolutions are pursuant to Section 125.38, Florida Statute authorizing the conveyance of County property. The Assignment of Easements is the instrument assigning the easement rights acquired by the County for the project in order to maintain Barnes Boulevard and ancillary improvements to the City. The Release of Temporary Construction Easements is to officially release the County's interest in those temporary easements that were needed to perform certain construction related work pertinent to the project. The Drainage Easement allows for a drainage facility within a County owned parcel. The Utility and Drainage Easement allow for utility, drainage and other allied uses within a County owned parcel.

The City intends to accept these documents at their June 2, 2021 Council meeting.

#### **COUNTY DEED**

(STATUTORY FORM - SECTION 125.411, Florida Statute)

THIS DEED, made this 18 day of May 2021, between Brevard County, Florida, a political subdivision of the State of Florida, whose address is 2725 Judge Fran Jamieson Way, Viera, Florida, 32940, as the first party, and the City of Rockledge, a municipal corporation of the State of Florida, whose address is 1600 Huntington Lane, Rockledge, Florida 32955, as the second party,

(Whenever used herein, the terms "first party" and "second party" include all the parties to this instrument and their heirs, legal representatives, successors and assigns. "First party" and "second party" are used for singular and plural, as the context requires and the use of any gender shall include all genders)

WITNESSETH that the first party, for and in consideration of the sum of Ten Dollars, to it in hand paid by the second party, receipt whereof is acknowledged, has granted, bargained and sold to the second party, its successors and assigns forever, any interest it holds in the following described land lying and being in Brevard County, Florida, to wit:

The Parcel as fully described in Exhibit A, attached and incorporated by this reference, the first party transfers ownership, maintenance, and functional responsibility for Barnes Boulevard from the east terminus of the West Pond Basin at Cobblewood Drive to Fiske Boulevard and its associated roadway, retention pond, drainage systems, the applicable St. John's Water Management District (SJWMD) permit for the West Basin, as well as the traffic signals servicing the three signalized intersections at: 1) Henderson Way, 2) Three Meadows Drive and 3) Murrell Road with their associated facilities and controllers. Additionally, the first party transfers all riparian and littoral rights appertaining thereto, and all interests in subsurface oil, gas, and minerals pursuant to section 270.11(3), Florida Statute. In the event the property is not used, maintained or ceases to be used and maintained for a public roadway with associated drainage, the first party does not retain any right of reversion. First party conveys the property subject to any easements and/or rights-of-ways of record, and reserves to itself a perpetual drainage easement over, under, upon, above and through Parcel B to discharge drainage for stormwater treatment and attenuation into Parcel B, as further described in Exhibit A.

## **RESOLUTION NO. 21-** 059

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA, PURSUANT TO SECTION 125.38, FLORIDA STATUTES, AND SECTION 2-247, BREVARD COUNTY CODE OF ORDINANCES, AUTHORIZING CONVEYANCE OF COUNTY PROPERTY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Brevard County, Florida, a political sub-division of the State of Florida (hereinafter the COUNTY) owns a certain right-of-way and easements for a public road right-of-way within the City of Rockledge, a municipality incorporated under the laws of Florida (hereinafter the CITY); and

WHEREAS, the right-of-way and easements for said public road are referred to as Barnes Boulevard from the east terminus of the West Pond Basin of Cobblewood Drive to Fiske Boulevard (hereinafter the Barnes Project), which is further described in Exhibit A; and

WHEREAS, on November 26, 2002, the County and City executed an Interlocal Agreement regarding the Barnes Boulevard Widening Project (hereinafter the Interlocal); and

WHEREAS, paragraph 10 of the Interlocal states the County and City agree that upon completion of the construction project, to wit, September 14, 2018, the City will assume ownership and maintenance responsibilities of Barnes Boulevard from Murrell Road to Fiske Boulevard (including all retention/detention ponds and off-site acquisitions related to the project), two years after construction is complete; and

WHEREAS, upon review of the permit issued by the St. John's Water Management District for the West Pond Basin having permit number 4-009-102771-7 and as included in this transfer, County and City have determined that the logical point of terminus would be to coincide with the permit limits, which extends the limits east of Murrell to Cobblewood Drive; and

WHEREAS, Army Corps of Engineers permit number SAJ-2007-05926-SP-TSD will be transferred to the City as part of the transfer package, and the City has agreed to accept the transfer said permit; and

WHEREAS, the City has agreed to accept the east terminus at Cobblewood Drive; and

WHEREAS, the City has agreed to accept ownership and maintenance responsibility for street and traffic lights including related equipment for the three (3) signalized intersections (Henderson Way, Three Meadows Drive, and Murrell Road) within the right-of-way as described herein; and

WHEREAS, the County Deed with attached Exhibit A, an Assignment of Easements, an assignment of the St. Johns Water Management Permit and assignment of the Army Corps of Engineer permits will effectuate the intent of the Interlocal, and

WHEREAS, the CITY has applied for a conveyance of the Barnes Project via the Interlocal, which shall promote the community interest and welfare of the CITY; and

WHEREAS, the COUNTY agrees that the CITY's proposed use of the property for roadway purposes will promote public health, safety or welfare, will serve the public interest, will serve a public purpose; and the COUNTY has determined that said property is not needed for COUNTY purposes, and desires to cooperate with and assist the CITY by conveying the property.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Brevard County, Florida, that:

- The foregoing recitals are true and correct and incorporated to this Resolution by this reference.
- 2. The Barnes Project property is fully described at Exhibit A, which is attached and incorporated by this reference. The Barnes Project is located within the boundary of the CITY, and is not needed for COUNTY purposes.
- 3. The COUNTY finds the CITY has requested the conveyance and the CITY will use and maintain the Barnes Project as a public roadway to provide safe and well-kept roadways for the community.
- 4. In the event the Barnes Project is not used, maintained or ceases to be used and maintained for a public roadway, the COUNTY does not retain any right to reenter and repossess the property.
- The COUNTY authorizes the Chair, Board of County Commissioners, to execute all necessary documents to convey the Barnes Project as described in Exhibit A to the City by County Deed at nominal consideration pursuant to the terms of the Interlocal.
- 6. This Resolution shall take effect immediately upon its adoption.

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA, PURSUANT TO SECTION 125.138, FLORIDA STATUTES, AND SECTION 2-247 OF THE BREVARD COUNTY CODE OF ORDINANCES AUTHORIZING THE ASSIGNMENT OF EASEMENTS, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Brevard County, Florida, political subdivision of the State of Florida (hereinafter the COUNTY), holds easement interests in certain real property described in Exhibit A within the City of Rockledge, a municipality incorporated under the laws of Florida (hereinafter the CITY); and

WHEREAS, COUNTY obtained the permanent easements for varied public uses such as sidewalks, public utilities, drainage, wall, landscape, roadway access, and other allied public uses related to the Barnes Boulevard Widening Project; and

WHEREAS, the CITY has applied to COUNTY to acquire said easement interests when the COUNTY conveys Barnes Boulevard from the east terminus of the West Pond Basin at Cobblewood Drive to Fiske Boulevard (hereinafter the Barnes Project) to CITY; and

WHEREAS, the COUNTY agrees that assigning the easement interests is beneficial to the citizens of Brevard County, and promotes the public health, safety or welfare, will serve the public interest, will serve a public purpose, and benefit the community interest and welfare of the CITY; and

WHEREAS, the COUNTY agrees the easement interests are not needed for other COUNTY purposes because the COUNTY is conveying the Barnes Project to CITY, and the COUNTY agrees the easements are needed by the CITY and desires to cooperate with and assist the CITY by conveying the easement interests; and

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of Brevard County, Florida, that:

- 1. The foregoing recitals true and correct and incorporated to this Resolution by this reference.
- 2. The COUNTY finds the CITY has requested certain easement interests be transferred to it, and that such transfer is necessary for CITY to properly maintain Barnes Boulevard, a public roadway, for the good of the community with sidewalks, public utilities, drainage, wall, landscape, roadway access, and other allied public use easements.
- 3. The COUNTY finds the easement interests are not needed for COUNTY purposes since the CITY will own and maintain the Barnes Project but are needed for CITY purposes.
- 4. In the event any of the easement interests are not used, maintained or cease to be used and maintained for an easement's designated purpose, the COUNTY does not retain any right of reversion.

- 5. The COUNTY authorizes the Chair, Board of County Commissioners to execute all necessary documents to convey the easement interests at nominal compensation to the CITY, as said interests are described in Exhibit A, which is attached and incorporated by this reference.


