
In accordance with Florida Statutes, 200.065 (4), and Chapter 28924, Special Acts, Laws of Florida, the following information is submitted.

RESOLUTION

WHEREAS, Chapter 200, Florida Statutes, and Chapter 2003-362, Laws of Florida, provide that it shall be the duty of the NORTH BREVARD COUNTY HOSPITAL DISTRICT BOARD to determine the amount required during the ensuing fiscal year for the purpose of establishing, constructing, equipping, operating, maintaining, or repairing the PARRISH MEDICAL CENTER, operated by the NORTH BREVARD COUNTY HOSPITAL DISTRICT BOARD: and

WHEREAS, the said board has determined the amount to be required during the ensuing fiscal year for the purpose of establishing, constructing, equipping, operating, maintaining, or repairing said Hospital;

NOW, THEREFORE, BE IT RESOLVED by the NORTH BREVARD COUNTY HOSPITAL DISTRICT BOARD in special session assembled this 23rd day of September, 2019 adopted Fiscal Year 2019-2020 Final Millage Rates following a public hearing as required by Florida Statute §200.065, and that the amount required, which shall be provided by an ad valorem tax, during the 2019-2020 fiscal year for the purpose of establishing, constructing, equipping, operating, maintaining, or repairing PARRISH MEDICAL CENTER, operated by the NORTH BREVARD COUNTY HOSPITAL DISTRICT BOARD, and it is hereby determined to be as follows:


OPERATING/MAINTENANCE MILLAGE LEVY \$0.0000 per \$1,000

The Rolled-back Rate (as defined in Florida Statutes §200.060(1)) is the same as the proposed Millage Levy, and therefore, the Millage Levy represents a zero percent (0%) increase over the "Rolled-back Rate".

BE IT FURTHER RESOLVED that a copy of this Resolution be furnished to the Board of County Commissioners, Tax Collector and Property Appraiser of Brevard County, Florida, and the Department of Revenue, State of Florida.
