This action allows for budgeted revenue in the amount of \$6,609.60 per fiscal year. The total revenue amount for the 60 month extension equals \$33,048.00. This is an increase of \$1,036.80 from the previous five years.

#### Requested Action:

It is requested that the Board approve and authorize the Chair to execute the attached Lease Modification #4 to Agreement with the State of Florida, Bureau of Leasing Department/Management Services, Division of Plant Industry for the lease of 324 square feet of office space at the UF/Extension Services, Agriculture Center in Cocoa.

#### **Summary Explanation and Background:**

This lease modification continues a longstanding cooperative relationship with the Florida Division of Plant Industry, who leases space for two employees involved in inspecting nursery production and garden center businesses. The Division clients often utilize the educational resources available through UF/Extension Services. The funds generated by the lease are included in the UF/Extension Services budget.

This modification will extend the term of the lease for an additional 60 months, from July 15, 2021 to July 14, 2026. This extension of the lease also includes a restructure of the rental rate with an increase of 3.24% with a new monthly rate of \$550.80


