## **HISTORIC BREVARD**

### **HISTORICAL FACTS PROVIDED BY THE BREVARD COUNTY HISTORICAL COMMISSION**

Due in part to a new ease of transportation made possible by the automobile, Brevard County began experiencing a period of rapid growth and speculation during the early 1920s. The 'boom' wasn't to last and fully three years before the Stock Market crash of 1929; Florida was already deep in depression.
