Requested Action:

It is requested the Board authorize the Chair to execute Amendment 11 to Lease Number 3485 with the Board of Trustees of the Internal Improvement Trust Fund of the State of Florida and following Amendment 11 to Lease Number 3485 authorize the Parks and Recreation Department Director to amend the associated Management Plan as needed.

Summary Explanation and Background:

In 1984 the voters of Brevard County approved a referendum for the acquisition and development of beach and riverfront property in the County. In an effort to increase the amount of funding for the acquisition of oceanfront lands, the County applied for and received monies under the State's Save Our Coast Program for land purchases in the South Beaches. The State received title to the properties and then leased to the County the responsibility for development, operation, and maintenance. The original Lease Agreement was effective June 12, 1987 and will terminate in 2057.

Save Our Coast Properties currently includes more than 20 parcels both developed and undeveloped. Amendment 11 will add a 3.25-acre parcel adjacent to land currently managed by the Parks and Recreation Department. The parcel was recently acquired by the State. For the last fifteen years Brevard County has utilized this site, while under private ownership, for beach restoration projects and other emergency beach access needs. Adding this parcel to the County lease will allow continued use for the projects.

AMENDMENT NUMBER 11 TO LEASE NUMBER 3485

THIS LEASE AMENDMENT is entered into this May of September, 2022, by and between the BOARD OF TRUSTEES OF THE INTERNAL IMPROVEMENT TRUST FUND OF THE STATE OF FLORIDA, hereinafter referred to as "LESSOR" and BREVARD COUNTY, FLORIDA, a political subdivision of the State of Florida, hereinafter referred to as "LESSEE";

WITNESSETH:

WHEREAS, LESSOR, by virtue of Section 253.03, Florida Statutes, holds title to certain lands and property for the use and benefit of the State of Florida; and

WHEREAS, on December 5, 1989, LESSOR and LESSEE entered into Lease Number 3485 (the "lease"); and WHEREAS, LESSOR and LESSEE desire to amend the lease to add land to the leased premises.

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein, the parties hereto agree as follows:

- 1. The legal description of the leased premises set forth in Exhibit "A" of Lease Number 3485 is hereby amended to include the real property described in Exhibit "A" attached hereto and by reference made a part hereof.
- 2. It is understood and agreed by LESSOR and LESSEE that in each and every respect the terms of Lease Number 3485, except as amended, shall remain unchanged and in full force and effect and the same are hereby ratified, approved and confirmed by LESSOR and LESSEE as of the date of this amendment
- 3. It is understood and agreed by LESSOR and LESSEE that this Amendment Number 11 to Lease Number 3485 is hereby binding upon the parties hereto and their successors and assigns.

4. This lease amendment may be executed by electronic signature, which shall be considered as an original signature for all purposes and shall have the same force and effect as an original signature. Without limitation, "electronic signature" shall include faxed versions of an original signature or electronically scanned and transmitted versions (e.g., via pdf) of an original signature.


