Subject:

Public Hearing: RE: Inventory List of all Real Property within the County's Jurisdiction that is Appropriate for use as Affordable Housing.

Fiscal Impact:

There isn't a fiscal impact to the review and adoption of a Resolution of the inventory list of the County's real property to which the County holds fee simple title and has been found to be appropriate for the use as affordable housing.

Dept/Office:

Central Services/Housing and Human Services

Requested Action:

It is requested that the Board conduct a public hearing:

- 1. To hear public input on the inventory list of property that is within the County's jurisdiction and the County holds fee simple title and is appropriate for use as affordable housing; and
- 2. Review and make any revisions to the inventory list at the conclusion of the public hearing; and
- 3. Adopt the Resolution that includes an inventory list of real property within the County's jurisdiction to which the County holds fee simple title, and which has been found to be appropriate for use as affordable housing.

Summary Explanation and Background:

As required by Chapter 2023-17, Laws of Florida, the County is required by October 1, 2023, and every 3 years thereafter, to prepare an inventory list of all real property within the County's jurisdiction to which the County or any dependent special district within its boundaries holds fee simple title that is found to be appropriate for use as affordable housing.

The Housing and Human Services Department reviewed the County's surplus property and has identified the following properties as appropriate for use as affordable housing:

RESOLUTION NO. 23-100

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS, BREVARD COUNTY, FLORIDA FOLLOWING PUBLIC HEARING AND REVIEW OF THE INVENTORY LIST OF ALL REAL PROPERTY WITHIN ITS JURISDICTION IN WHICH BREVARD COUNTY, FLORIDA HOLDS FEE SIMPLE TITLE AND WHICH IS APPROPRIATE FOR USE AS AFFORDABLE HOUSING.

WHEREAS, Chapter 2023-17, Laws of Florida, requires Brevard County by October 1, 2023, and every 3 years thereafter, to prepare an inventory list of all real property within its jurisdiction to which the County or any dependent special district within its boundaries holds fee simple title and which has been found appropriate for use as affordable housing; and

WHEREAS, Chapter 2023-17, Laws of Florida states the Board of County Commissioners of Brevard County, Florida must review the inventory list at a public hearing and may revise it at the conclusion of the public hearing; and

WHEREAS, the Board of County Commissioners held a public hearing on September 12, 2023 and reviewed the inventory list of real property within the County's jurisdiction, which the County holds fee simple title, and is appropriate for use as affordable housing; and

WHEREAS, Chapter 2023-17, Laws of Florida requires that the inventory list, which has been found to be appropriate for use as affordable housing, must include the address and legal description of each such real property and specify whether the property is vacant or improved; and

WHEREAS, Chapter 2023-17, Laws of Florida requires that the inventory list, which has been found to be appropriate for us as affordable housing, shall be made publicly available on the County's website; and

WHEREAS, the Board of County Commissioners shall adopt a resolution that includes an inventory list of such property following the public hearing.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF BREVARD COUNTY, FLORIDA, that:

1. The Board of County Commissioners of Brevard County, Florida heard public comments regarding the inventory list, referenced herein as Attachment A, of all real property within the County's jurisdiction to which the County holds fee simple title which has been found appropriate for use as affordable housing.

- 2. The Board of County Commissioners of Brevard County, Florida reviewed the inventory list at the public hearing referenced herein as Attachment A.
- 3. The Board of County Commissioners of Brevard County, Florida will make the inventory list publicly available on the County's website to encourage potential development.
