Mr. Klimkowski,

Item D. on the agenda for the Board's December 19, 2023 meeting expressly sought approval of minutes for both the Board's November 21, 2023 Organizational/Regular Meeting, and the Board's December 7, 2023 Zoning Meeting. When the Chair called the agenda item for consideration, he verbally shortened the description of the item to reference only the November 21, 2023 meeting. However, the intent of the Board was obviously to approve both sets of minutes as requested in the written agenda. Notably, no commissioner asked to discuss the December 7, 2023 meeting minutes, or raised any issue as to the accuracy or sufficiency of those minutes at the time Agenda Item D. was approved.

Subsequently, during the Public Comments portion of the meeting, you questioned whether both sets of minutes had been approved. Commissioner Pritchett stated that the Board did approve both sets of minutes and Chair Steele agreed. If any of the Board members had a different understanding, or any objection or revision to the December 7, 2023 minutes as presented, they had a second opportunity to address the issue at that time. Rather, the Board indicated their assent by silence.

Thank you for raising the issue during the meeting and allowing the Board to further clarify that they had in fact approved the minutes for both meetings as requested in the written agenda.

I trust this message finds you well. I write to urgently address a matter of critical concern arising from the recent BoCC sessions, particularly regarding the dissemination of accurate information and the approval process of meeting minutes.

It is imperative to highlight a disconcerting trend of misinformation persisting within the Dias. Rather than being met with transparency and clarity, the recent BoCC proceedings have regrettably been marred by inaccuracies that demand immediate rectification.

Upon thorough scrutiny, it has come to my attention that the Dec 7, 2023 Zoning meeting minutes were not duly approved during the session, contrary to the organizational meeting. Such discrepancies cast a shadow over the integrity of our processes and call into question the reliability of information disseminated.

Moreover, an egregious error was observed in the agenda item D., which was erroneously labeled as a regular meeting instead of a zoning meeting. This divergence from the official agenda not only muddles proceedings but also undermines the fundamental accuracy expected in these discussions.
