Justification:

This budget change request is a line-item transfer to shift capital funding associated with Facilities projects included in the FY23 budget. Upon demolition of the Brevard County Detention Center Women's Annex Walkway, it was noted that support beams are rusted beyond repair and require complete replacement. This damage is significantly more than expected, leaving a \$175,000 shortfall to complete the project entirely. The needed funds will be reallocated from the unspent salary and benefits due to vacancies (\$125,000), as well as savings from the Brevard County Detention Center Kitchen Kettle and Water Treatment Project (\$50,000) which came in lower than anticipated.

Alternative:

If this budget change request is not approved, Facilities will not be able to complete this critical project and reopen the Annex Walkway. Currently female inmates are unable to be housed in the Annex, creating hardship on Brevard County Sherriff Office.
