WHEREAS, MATT CHRISTOPHER CULVER, born in California on this day in 1969, has been a resident of Brevard County for 24 years; and

WHERAS, MATT earned Bachelor of Science degrees in Ecology, Evolution and Conservation Biology, and Biological Oceanography from the University of Washington in 1997; after graduation MATT spent three years with the Peace Corps in Panama and the Crisis Corps in the Dominican Republic, where he met his wife Ingrid, while facilitating rural farming projects and coordinating with relief agencies before returning to the States to pursue graduate studies; and

WHEREAS, MATT earned his Master of Science in Coastal Zone Management from the Florida Institute of Technology in 2003 after having developed his Master's Research Project on Integrated Watershed Management in Honduras; and

WHEREAS, MATT started his public service career in 2003 as an Environmental Specialist with the Florida Department of Environmental Protection in Marathon, and moved to the City of Titusville as a Development Supervisor in 2004, before joining Brevard County as an Environmental Specialist in 2006; and

WHEREAS, MATT through diligent effort and dedication advanced to his present position as Boating and Waterways Program Coordinator in 2007 where he has served as staff liaison to two Board-appointed groups, the Marine Advisory Council and the District 2 Canal Dredging Committee; during his tenure, has overseen the removal of 327 derelict vessels from the Indian River Lagoon, thereby permanently eliminating potential contamination and navigational hazards; and

WHEREAS. MATT'S contributions have included countless weekend special events, Manatee Protection Plan and Comprehensive Maritime Management Master Plan development, coordination with agencies and marinas, emergency response to vessels adrift during and after storms, and general interagency marine law enforcement coordination; and
